Remove existing slate roof down to decking and inspect

Any wood work will be quoted upon discovery

Install Ice and water shield to all slopes, valleys, and protrusions

Install cleated Copper valleys

Install Hand nailed North Country Black slate to all slopes currently slate (excluding Turret)

Copper hat vents will be installed as needed to properly vent roof

Install custom fabricated hand soldered copper chimney flashing to all chimneys connected to slate roof

Install customer choice of saddle slates or copper ridge roll to all hips and ridges

Turret Slate Roof \$18,680.00

Remove all slate from turret down to decking and inspect

Any wood work will be quoted upon discovery

Install ice and water shield to entire face of turret and surrounding valleys/ roof pans

Install custom fabricated hand soldered copper valleys and roof pans at he base of turret

Install hand cut North Country Black slates to taper and conform to turret circumference

Install a custom fabricated copper cap at the peak of turret to provide a clean finish

Scaffolding/Setup \$16,475.00

Set up for new slate roof will be be done with scaffolding at all eaves to reach approximately waste high at the eave. All scaffolding will be to OSHA specifications. This will allow for crew and staging of material. A dumpster will be on site in a designated area for all job related debris.
