

Our team leaders branched off from the leading skatepark contractors, where they developed industry building standards and high levels of craftsmanship, in order to shape a core company interested in building more creative parks with community minded principles. Our designs are innovative, balanced, and engaging for all styles and levels of skateboarding. We utilize building techniques that ensure long-lasting parks with low long-term maintenance. Our approach to park designing and building involves a high level of collaboration in order to develop projects unique to the community it will serve. Hunger Skateparks highest aim is not to build parks that few have the ability to enjoy, but to create balanced and creative parks that inspire a large audience. SKATEPARK CONSTRUCTION

Hunger Skateparks uses traditional and sound building methods as the backbone of every skatepark project, in addition to the specialty nuances crucial to building successful parks. By utilizing these techniques, we endure long-lasting parks with low long-term maintenance. We have seen what happens when parks are not built to a standard and then fail to skate well or withstand the test of time. We avoid these problems before they exist in an effort to continually evolve the trade.






SKATEPARK DESIGN CONCEPT | SCHEMATIC | 3D | CONSTRUCTION DOCUMENTATION

Our approach to park design and building involves a high level of collaboration in order to develop projects unique to the users it will serve. The site dictates much of the design possibilities, and that is where we begin the process. We visit the site, take grades, and establish constraints. Information gathered through a geotechnical investigation, survey, landscape architects, and engineers will add to the background knowledge prior to starting site layout.

We generally have 2-3 public meetings, along with consistent communication with the owners to provide a completely transparent process. Throughout the process, we create an open channel of communication through email, social media, and the use of hashtags so that all users can contribute ideas easily. The collaboration with local stakeholders influences our Pre Design and Concept Design phases in a non linear way. As information is shared and gained, the design adjusts and develops further to meet the needs of stakeholders.



Skateable Art and Signature Pieces

Hunger considers skateparks to be potential works of public art, and includes signature pieces and skateable art into every project. We draw inspiration for the art directly from the community and region it will inhabit, and at times using local artist craftsman to collaborate in the sculptural build.







WILLARD SKATEPARK

INDIANAPOLIS, INDIANA

Located near downtown Indianapolis, Indiana, this 13,000 square foot park is the first skatepark built in Indy in 20+ years. The design includes re-purposed granite ledges along the flat-ground entrance. The southern street run is flanked by a giant hip and a street island with hubbas, euro manual set up, and 2 down rails. A flow bowl is cradled around the street areas, and has a kong wall, throne, camel back humps, extension with pool coping and an over-vert pocket.

When looking for moments of art for the park, we decided to create dedicated memorial moments to honor the city, the history of the park, and a few positive skateboarders who were killed tragically during the process of designing and building the park. All the granite was re-purposed from the iconic city government building ledges, and used throughout the park in features and as seating. The 2 up 2 down granite planter is a Pam Am Plaza inspired downtown Indy spot homage. The flat rail says INDIANAPOLIS in ASL, to honor the history of Willard Park as the first school for deaf in Indianapolis.


BATESVILLE SKATEPARK BATESVILLE, INDIANA

The design is a combination of transition and street with an emphasis on friendly beginner flow with potential to grow. Ask anyone regionally what they know about Batesville, and they will likely say 'coffins' because of the local casket building industry. Of course that shape had to be included into the design in a few different places including the rain gardens and the coffin extension in the mini ramp. Creative transition areas sweep the street areas on all sides. The bowl is a 3 pocket (8 ft, 6 ft, 4 ft) with a roll in, raised organic middle section, pool coping, and a blue and orange gradated tile band that reflects the diagonals of the coffin shapes.

EVANSVILLE SKATEPARK EVANSVILLE, INDIANA

Recently completed in December 2023, the Evansville skatepark is the largest skatepark in the state of Indiana. It is located along the banks of the Ohio river within Sunset Park. The Park includes a street course, flowbowl, pool bowl, big jump line and a multi-use derby track/ s.k.a.t.e. area. The innovative derby track/S.K.A.T.E loop was developed in conjunction with local roller skaters that wanted something their community could use equally. The Artistic inspiration for many of the details throughout the park came from a combination of the epic sunsets along this bend of the Ohio River and the nearby Mississippian Angel Mounds- an incredibly unique and well preserved 1000 yr old settlement of the natives to this area. As fellow mound builders, we naturally gravitated towards their story and pulled symbolism of the sun from their culture and integrated it into the park.

VICTORY SKATEPARK

NASHVILLE, INDIANA

Nashville is a beautiful town with a historyi n the arts that attracts tourists from all over the midwest to visit the galleries, shops, and the legendary Brown County State Park. But skateboarding in the small tourist town of Nashville, IN has been outlawed for decades. With help from Patronicity, Tony Hawk Foundation, Brown County Tourism Board and many individual and private donors, Isaiah Smith and his mom Colleen raised the money to build the community its first skatepark with benches, swings and landscaping to beautify the area.

The 5,000 s.f. park site layout includes a 3 pocket bowl with varying elevations and a custom stamped tile band connected to a long street course. Street course includes a flat rail, down rail, multiple ledges and pad combos, target ball feature, hubbas, bank to curb, and a long quarter with a 7' skateable redbud leaf. The leaf projects out of the long quarter, with scored veins and a decorative acid stain. The park is surrounded by nature and easily boasts the best sunset sessions in Indiana.






