- (8) 2' diameter concrete bases, 8' in overall length with 2' exposed above grade.
- Conduit and wire from ground box on South side of courts to each pole.
- We inlcude all excavation, backfill and compaction of trenches.
- We include the cost of all concrete for bases.
- We include lighting controls as a stand alone unit that is installed on-site utilizing LSI Airlink Blue.
- Engineering cost are included.
- Prevailing wage rates are included.

## MID CITY ELECTRIC - STANDARD TERMS AND CONDITIONS FOR PROPOSAL

Wherever the words "Mid City Electric" and "Customer" appear hereafter they shall refer to the respective parties named on the previous page and signatory hereto

1. This proposal is in accordance with Mid City Electric's understanding of the requirements of the project from information which the Electrical Contractor received from the Customer, or its agent, and if written plans and specifications are furnished by the Customer, Mid City Electric's interpretation of them, such written plans and specifications being hereby incorporated by reference in this proposal. Mid City Electric assumes no responsibility as to the accuracy or suitability of such plans and specifications. It is further understood and agreed that this proposal and contract does not include any labor or materials not specifically mentioned herein. Unless otherwise provided in the plans and specifications, Mid City Electric shall have the right to select all materials. When specified materials are unavailable, Mid City Electric shall have the right to use any existing materials if suitable and to keep any materials that have been replaced by new materials.

2. Payments shall be made on completion of this contract if the work is completed within a period of 30 days. If the work continues beyond a period of 30 days, or is delayed for reasons beyond the control of Mid City Electric, monthly progress payments shall be paid in an amount equal to 90% of the first 50% of the work and 100% of the last 50% of the work. Payment shall be made to Mid City Electric by the 10th of the month following the date of any billing. Mid City Electric shall not be required to proceed with the installation of any work if the payments applying on the same have not been made as specified in the contract. In the event suit is filed by Mid City Electric to collect any monies due him hereunder and or to enforce any other provisions of the contract, the Customer shall agree to pay all costs and all reasonable attorney fees incurred together with interest on all of the unpaid balance at the highest legally permissible rate in the state in which the project is located.

3. Changes and additional work ordered by the Customer shall constitute additions to this contract and the amount to be paid for the same shall be determined by the Customer and Mid City Electric at the time said work is ordered. If for any reason the parties should fail to agree upon the amount to be paid, then the Customer shall pay a reasonable price therfor computed on a Time and Materials basis. If the change requested by the Customer shall reduce the amount of labor or material, or both, that Mid City Electric shall furnish for the project, then the Customer and Mid City Electric shall agree at the time that the change is requested on the amount of the credit that shall be given by Mid City Electric to the Customer, and, if they do not agree upon the amount of the credit, then the reasonable value of the deducted labor and or unused materials less restocking charges shall be reddited to the Customer. Mid City Electric shall receive written orders are not neceived, this shall not affect the right of Mid City Electric to receive payment as above for said labor and materials furnished. Payments for additions or changes shall be under the same terms and conditions in Paragraph 2.

4. All prices quoted herein are firm upon acceptance of this proposal covers the connection of machinery and equipment, it is based upon one point wiring attachment to each machine, unless plans and specifications clearly set forth in detail any different wiring which is to be installed on such equipment or machine, or where applicable wire the purpose under the applicable electric code. It is further stipulated that the Customer will assume the same responsibility for any materials or equipment to furnished by Mid City Electric for in all expe

- as if originally added hereto.

  11. If the Customer shall enter into a sale or shall sell all or any part of the premises herein involved, the full amount remaining unpaid on this contract becomes due and payable within 48 hours after date of such sale or agreement of sale at the option of Mid City Electric. Title to any of the material sold or installed hereunder by Mid City Electric shall remain in Mid City Electric until all the terms hereof have been complied with, and in the event such materials are affixed to realty, it is expressly understood and agreed that they shall remain personal property subject to removal by Mid City Electric. The Customer hereby waives any and all claims for damage to said realty or buildings caused by the removal of said materials or any part thereof and, if the Customer is no the owner of said realty or buildings, the owner likewise waives such claims by countersigning this contract or, in the absence of the owner's signature, the Customer accepts full liability for such claims made by the owner.

  12. The price has been determined on the basis of straight time and normal work week. No overtime will be worked unless ordered by Customer or his representative. In the event overtime is worked, the overtime premium rates plus Mid City Electric's regular markup for overhead and profit will be paid as an extra.
- 13. Upon acceptance, it is understood and agreed that this contract cannot be cancelled except by mutual consent, and then only after payment to Mid City Electric for all labor, material and job costs incurred to the date of cancellation plus his overhead and profit thereon. This contract embodies the entire agreement between the parties except as otherwise stated herein, and may only be revised or modified by an appropriate
- fully-executed written amendment hereto.
