Community Environmental Health

Rabies Control – 100 exposure events in Franklin County were reported to Franklin County Public Health during this quarter. No exposure incidents were reported to FCPH from within Bexley between January 1, 2024, and March 31, 2024.

Public Swimming Pools –

Franklin County Public Health currently has 395 licensed recreational water facilities. There are eight licensed pools, spas, or special use pools in Bexley. The licensing year is from June 1, 2023, to May 31, 2024. Standard pool inspections are conducted at least twice per licensing year. Pool inventory inspections are conducted once per year. Inventory inspections document pool equipment including pool pumps, filters, chemical feeders, drain covers, and other facility specific equipment. Four inspections were conducted in Bexley during this quarter at the locations listed below:

Body Art -

Franklin County Public Health currently has 92 body art facilities. The licensing period is from January 1, 2024, through December 31, 2024. Body art includes traditional tattoo and body piercing, but it also includes permanent make-up or reconstructive procedures such as microblading, micro-needling, scalp micropigmentation, and scar camouflage. FCPH licenses two tattoo businesses in Bexley, both of which perform permanent makeup and/or reconstructive procedures. FCPH inspects body art facilities at least once during the licensing period. Two consultation inspections were conducted during this quarter and are listed below.
