#### **Body Art –**

Franklin County Public Health (FCPH) currently licenses 96 body art facilities for the licensing period of January 1, 2025, through December 31, 2025. Licensed body art services include traditional tattooing and body piercing, as well as permanent makeup and reconstructive procedures such as microblading, micro needling, scalp micropigmentation, and scar camouflage. Within the City of Bexley, FCPH licenses two tattoo establishments, both of which offer permanent makeup and/or reconstructive procedures. As part of its regulatory oversight, FCPH conducts inspections of body art facilities at least once per licensing period. No inspections were conducted in Bexley during this quarter.

### Vector Control

Over 150 traps are set throughout Franklin County each week. Bexley is divided into two zones which are listed in the table below with total mosquitos collected for West Nile Virus (WNV) testing. The numbers in the table reflect only female mosquitos. This is because only female mosquitos bite and are capable of transmitting WNV. As mosquitos test positive for WNV, the area is treated to reduce the number of adult mosquitos.
