Commonwealth Park Plaza Public Workshop

Work has begun on finalizing the Commonwealth Plaza plan. A public workshop will be held March 6th in order to provide a park update and to solicit feedback on finalizing the details of the plaza that will serve to help harmonize the east and west sides of the park.

Outdoor Reading Room Update - Roles of the Stakeholders

As the Outdoor Reading Room at the Bexley Public Library and Torat Emet is taking shape, details are firming up on how to finance, install, and maintain the proposed park. The proposal is that the Library and Torat Emet would negotiate easements to allow the library to maintain and manage the park. The City is helping to convene the process and assist with the design and project oversight, and will be assisting with funding the park as an eligible project of the Main Street Streetscape TIF. The City would then assist with construction oversight and portions of the initial maintenance of the park in the first year while plant material is being established. The library would then proceed with park maintenance in the years to come.



Mayor's Update to City Council

Ferndale/Mayfield Action Update

Yesterday afternoon we received the completed Phase II environmental survey for the last 9 properties located on Ferndale and Mayfield that had not previously had a Phase II survey. All 9 properties were contaminated at a similar level to the other properties on top of the Holtzman landfill. Letters are being sent to tenants to notify them of the contamination and provide action items, and letters are being drafted to landlords pursuant to the City's nuisance sites ordinance.

Trinity Apartments Update

Capital University announced this week that they are offering the Trinity Apartments site for sale. We have received numerous inquiries from developers over the years, and will continue to provide support and assistance as requested.

HR Audit Update

We received an initial draft of our HR audit last week and met with the HR firm that performed it to discuss the findings. Once the report has been finalized, we will present its findings and recommendations to council, some of which will involve detailing additional proposed HR expenditures which were budgeted for in advance as part of the 2023 budget process.

Health Works Franklin County (HWFC) is a cross-sector, collective impact coalition designed to bring together partners from across the entire public health system with a focus on social determinants of health to guide and inform FCPH's next community health improvement plan. Additional meetings of HWFC will be held in the next few months as FCPH works to finalize a new plan for our health jurisdiction by May 2023. Guidance and expertise from City Leaders is critical to inform this effort, and you are invited to join this virtual meeting on February 23 from 10:00 am - 12:00 pm.


