



## **City Council Meeting Minutes**

Tuesday, May 9, 2023

### **1) Call to Order**

Council President Markham called the meeting to order at 6:03 pm.

### **2) Roll Call of Members**

Mayor Kessler and Chief Lewis both spoke about the two new officers and the three newly promoted sergeants.

**8) Auditor’s Report**

Mr. McPeck reported the satisfactory results of his monthly audit of invoices over \$5,000.

**10) Administrative Update**

a) Finance Department Update – Beecher Hale

No report and no questions.

b) Police Department Update – Chief Gary D. Lewis, Jr.

Chief Lewis had no additions to his written report. Ms. Lampke thanked Chief Lewis and Lieutenant Overly for attending the Bexley Women’s Club event. Ms. Saad asked Chief Lewis to highlight Super Saturday, which he did.

c) Recreation Department Update – Mike Price

Mr. Price had no additional items to report. Ms. Feibel mentioned how many students came to Jeffrey Mansion for prom pictures and how exciting that is. Mr. Marcellino also added it's a good marketing opportunity. Ms. Lampke complimented the pool membership numbers and Ms. Saad relayed a story of a lifeguard working in the community this year.

Mr. Kessler then invited Mr. Price to talk about the prototype signs on display in the lobby for park signage.

d) Service Department Update – Andy Bashore

Mr. Bashore didn't have any additional information to add to his report. Mr. Bashore did answer a question about the work on Drexel, which is proceeding according to plan. The Mayor highlighted an upcoming project from Columbia Gas.

e) Mayor's Update

Mr. Kessler then covered some highlights from his report, including the upcoming groundbreaking at Commonwealth Park and an update on the strategic plan refresh and an upcoming MORPC grant opportunity for EV chargers. Mr. Kessler then mentioned a couple of upcoming opportunities to barbecue, including an upcoming event for Bexley Police retirees.

**12) Third Readings (No Speaker Slip Required)**

a) Ordinance 13-23 to provide for an advance to the Main Street Streetscape TIF Fund from the general fund, repayable over a ten-year period commencing in 2024, in order to provide funding for TIF-eligible public space improvements, introduced by Monique Lampke on April 11, 2023.

Mr. Fishel read the ordinance and Ms. Lampke provided some additional information and background on this ordinance.

Ms. Lampke moved to adopt Ordinance 13-23.

Ms. Robinson seconded.

**13) Second Readings (Speaker Slip Required)**

- a) Ordinance 14-23 authorizing the Mayor to accept the donation of real property from the Columbia Place Association and providing for the amendment of the Columbia Place PUR, conditional upon the completion of certain repairs and upgrades under the conditions outlined herein introduced by Lori Ann Feibel on April 25, 2023.

Mr. Fishel read the ordinance and Ms. Feibel discussed the background and rationale behind this ordinance. Mr. Kessler highlighted some of the specific changes to this ordinance. Council members discussed this and asked questions before moving on.

- b) Ordinance 15-23 to Amend 618.15, Dogs on City Park and Recreational Property, introduced by Jessica Saad on April 25, 2023.

Mr. Fishel read the ordinance and Ms. Saad discussed the background and logic behind this ordinance.

**14) First Readings (Speaker Slip Required)**

- a) Resolution 2-23 to adopt the Tax Budget for calendar year attached hereto as Exhibit A, introduced by Monique Lampke on May 9, 2023.

Mr. Fishel read the ordinance and Ms. Lampke provided some background on this ordinance. Council members discussed some minor typographical changes needed on this ordinance.

**15) Tabled Ordinances**

- a) Ordinance 35-22 to amend Section 1060, in order to require recycling service to be provided at commercial, institutional, and multi-family properties within the City of Bexley, introduced by Lori Ann Feibel on September 13, 2022.

Mr. Markham moved to remove Ordinance 35-22 from the table for discussion.

**20) Finance Committee – Monique Lampke, Chair**

**21) Safety and Health Committee – Sam Marcellino, Chair**

Mr. Marcellino mentioned a recent conversation on the Board of Health about a potential ordinance to force those spraying mosquitos to inform neighbors, but no formal action there yet. Mr. Marcellino also encouraged elected officials to sign up for open office hours.


