

City Council Meeting Minutes

Tuesday, June 13, 2023

1) Call to Order

President Markham called the meeting to order at 6:04 pm and offered his thoughts to the people of Ukraine.

2) Roll Call of Members

Mr. Nathans presented scholarship awards to both Brooke and Joshua who shared briefly about their future plans. Mr. Nathans then shared some of the updates and work he's doing with planning for more public AED devices.

5) Ordinances with Special Guests

a) Ordinance 17-23 to approve and authorize the Mayor and the City Auditor to sign the Bexley Office Incentive Agreement and Tax Increment Financing Agreement between the City of Bexley and CSD Bexley LLC (COHatch); to provide incentives available for public infrastructure improvements in the Main Street Incentive District; and to establish the CSD Bexley LLC Account introduced by Matt Klingler on May 23, 2023. This is the second reading of this ordinance.

a. Matt Davis of CoHatch to present

Ms. Williamson read the ordinance and Mr. Klingler briefly discussed the background and rationale behind this ordinance and invited Mr. Davis of CoHatch to speak. Mr. Davis spoke about the history of the CoHatch company and his vision for the proposed development in Bexley. Several Council members asked questions about purpose, use, parking concerns, timelines, and other relevant information which Mr. Davis answered.

Mr. Markham thanked Mr. Davis for speaking and asked Mr. Kessler to walk Council through the proposed financial incentives which he did.
