Land Use Strategy 2.0 Update

As we continue to move forward on the Land Use Strategy refresh, several meetings have been scheduled with community partners to ensure the committee has a clear understanding of projects, developents, and plans that will impact the revision of this document.

Tirnity Apartments Sites Hearing Status

The Trinity Apartments developer has submitted early draft concepts for a site plan for the proposed development. The site is scheduled to have a preliminary review at the Board of Zoning and Planning on August 24th. At this hearing, board members will hear initial site plan concepts and provide feedback on them. The site plan is still in draft form, with multiple options being brought forward.
