



City Council Meeting Minutes

Tuesday, October 24, 2023

1) Call to Order

President Markham called the meeting to order at 6:03 pm.

2) Roll Call of Members

Mr. Markham invited Ms. Saad to introduce our special guests, Team Bexley. Ms. Kondracke spoke about Team Bexley which has raised funds for Pelotonia for fifteen years.

a) Recreation Department Update – Mike Price

Mr. Price highlighted some of the key points on his report and shared that they are in serious need for Halloween Patrol volunteers.

d) Police Department Update – Chief Gary D. Lewis, Jr.

Chief Lewis asked for questions first. Ms. Saad complimented the great work of the officers working on HEARTSafe Bexley. Chief Lewis reported on a meeting with the FBI Cincinnati Branch and BPD will have an officer join as a part-time (6:51 pm) Chief Lewis announced town halls at each synagogue which will be held to share steps the police are taking here in Bexley and offer opportunities for questions. Ms. Saad thanked Chief Lewis for these additions and asked him to keep us posted.

14) First Readings (Speaker Slip Required)

- a) **Resolution 7-23** accepting the amounts and rates as determined by the budget commission and authorizing the necessary tax levies and certifying them to the County Auditor, introduced by Monique Lampke on October 24, 2023.

Mr. Fishel read the ordinance and Mr. Kessler provided a brief synopsis and answered questions.

15) Tabled Ordinances

- a) **Ordinance 19-23** declaring the improvements to the former Trinity Seminary apartments site to be a public purpose; declaring such improvements to be exempt from real property taxation; requiring the owners thereof to make service payments in lieu of taxes; designating the public infrastructure improvements to be made that will directly benefit the real property; establishing a public improvement tax increment equivalent fund for the deposit of service payments; authorizing a revenue sharing agreement with the Bexley City School District; and authorizing a tax increment financing and redevelopment agreement with the developer of the site introduced by Matt Klingler on June 27, 2023.

Mr. Klingler moved to remove Ordinance 19-23 for brief discussion and update.

Mr. Markham seconded.

Motion passed 7-0.

Mr. Kessler walked Council through a slideshow detailing TIFs and how they can benefit cities and the different aspects. Mr. Marcellino asked about potential concerns that a longer 30 year TIF may create challenges that a 15 year TIF encountered, which Mr. Kessler answered. Mr. Klingler also shared that the TIF conversation prior to the vote occurred at the 1 hour and 19 minute mark on the Board of Education meeting recording. Mr. Klingler thanked the Mayor asked Council to take a closer look at this looking for a potential November vote. Council members discussed potential concerns and questions about approving the TIF conditionally, especially in light of changes or adjustments that could occur through the BZAP process.

Mr. Klingler moved to table Ordinance 19-23.

Mr. Markham seconded.

- b) **Ordinance 27-23** to amend Chapter 452.06, "Unattended Vehicles: duty to lock ignition, remove key, set brake, etc." in order to modernize provisions of this section and to expand restrictions on idling for the protection of both the health of citizens and the environment, and to add Section 618.25, Animals in Unattended Motor Vehicles, in order to protect the health and welfare of animals in unattended vehicles; introduced by Lori Ann Feibel on August 15, 2023.
- c) **Ordinance 35-23** to amend section 618.16(a)(5) of the Bexley Codified Ordinances to amend the definition of "Vicious Animal", and to reorder and amend existing Section 618.16(a)(8), introduced by Sam Marcellino on September 12, 2023.

Mr. Marcellino moves to remove Ordinance 35-23 from the table.

Mr. Markham seconded.

Ms. Feibel reminded everyone of the eco-challenge and encouraged everyone to take part. Ms. Feibel also spoke about a City Council nominee who was uninvited due to support of Israel and encouraged Council Members to refrain from partnering with organization. She shared something that was shared at a recent gathering regarding the struggles her children and family have faced, her feelings on the recent attacks, and her belief in the importance of supporting Jewish neighbors.

18) Recreation and Parks Committee – Jessica Saad, Chair

Ms. Saad shared some of the Mayor's words about Bexley being a safe space for all.

19) Finance Committee – Monique Lampke, Chair

Ms. Lampke reminded everyone to sign up for a budget meeting.

20) Safety and Health Committee – Sam Marcellino, Chair

Mr. Marcellino reminded anyone who has safety concerns in the City to reach out to the City to see how we can help. Mr. Marcellino also encouraged anyone to reach out if they'd like to discuss his stance on any of these issues and again encouraged everyone to reach out with concerns.

21) Strategic Committee – Jen Robinson, Chair

Ms. Robinson reminded everyone for of the upcoming Strategic Plan Public Workshop. Ms. Robinson shared some of her feelings on some of what's happening in Israel. Ms. Robinson then shed what she'd written regarding the attack on Israel and struggles she's witnessed and her belief that all innocent life must still benefit from our humanity.

22) Public Comments (No Speaker Slip Required)

Mr. Kessler shared some thoughts on his commitment to standing with the Jewish community in Bexley and ensuring the safety of these community members, sharing steps that have been taken to this purpose.



Public Comments:

For the purpose of receiving the orderly comments from all speakers desiring to address City business before Council, adopts the following policy:

- Any speaker addressing Council shall complete a Speaker Slip to be turned in prior to the start of the meeting.
- Any speakers who have public comments at the end of the meeting do not have to have a Speaker Slip but they do still need to provide their name and address.
- Please note that all public comments should pertain to City of Bexley business only.
- All reasonable comments must be made within a maximum of three (3) minutes when addressing City Council.
- Undue interruption or other interference with the orderly conduct of remarks is not permitted.
- Defamatory or abusive remarks are always out of order.
- If the subject of the comment is not on the Council Agenda, the public may discuss the City issue during the Public Comments portion of the meeting. If the subject of the comment is on the Council Agenda, the public may discuss the issue at the time the issue is addressed during the Council meeting.
- Violation of this policy may result in termination of the speaker's comments and/or removal from the meeting.
- President of Council reserves the right to limit the length and scope of all Public Comments.

While we are grateful to have you attend a City Council meeting. Please be sure to keep your presentation to a maximum of five (5) minutes in order to keep the meeting moving in an efficient and productive manner. Thank you for your understanding.
