

PROPOSED AMENDED ORDINANCE 38-23

By Monique Lampke:

An Ordinance to establish compensation rates for non-bargaining unit employees of the City of Bexley, effective as of January 1, 2024.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO

Section 1. That all non-bargaining unit employees shall be paid in accordance with attached Exhibit A.

Section 2. That all part time, temporary and casual employees will be paid hourly as follows:
