## GENERAL ADMINISTRATION

- Assisted Bryan Drewry and Bexley Minority Parent Alliance (BMPA) in development of Black History Month street light pole banner program and webpage: [bexley.org/blackhistorymonth](http://bexley.org/blackhistorymonth)
- Launched initial Mural Fest Planning Committee; Meeting biweekly to plan for event in late summer/early fall
