12. Second Readings (Speaker Slip Required)

- a) **Ordinance 35-24** authorizing appropriations for the calendar year beginning January 1, 2025; to reappropriate all unexpended OPWC project appropriations for 2025, to authorize general Fund Transfers in 2024 and to confirm the appointment of Marc Fishel as City Attorney, introduced by Jess Saad on October 22, 2024.

Mr. Fishel read the ordinance and Mayor Kessler shared an overview of the budget presentations, then shared some detail on the Mayor's Office and City Hall, answering questions along the way.

Ms. Martin spoke about the Auditor's Office budget with Mayor Kessler, which has been split out of the Finance Department to better delineate between the two separate functions of the Finance Department versus the Auditor. Ms. Martin and Mayor Kessler then answered some questions.

Mr. Klinger spoke about the Building and Planning Department budget and some changes he's made to design professional budgeting, a focus on Code Enforcement, etc.

Ms. Meyer spoke about the Development Department Budget, addressing development goals for 2025 as well as some updates on the work from the Sustainability Programs Coordinator role.

Mayor Kessler provided information on the City Attorney budget line.

Ms. Meyer then provided an overview of the Human Resources and Mayor's Court budgets, answering questions from Council Members on both.

Chief Lewis and Mayor Kessler then provided an overview of the Technology budget.

Mayor Kessler then covered budgets for the Boards and Commissions and City Council.

Chief Lewis then covered the budget for the Police Department, discussing some of the programs and replacement needs for 2025.

Mayor Kessler then provided an overview of other health and safety budget items.

- b) **Ordinance 36-24** to authorize the Mayor and Auditor to enter into a contract between the City of Bexley and Franklin County Public Health, introduced by Danny Hurley on October 22, 2024.

Mr. Fishel read the ordinance and Mr. Hurley provided a brief overview on this. Consent Agenda for next meeting.

- c) **Ordinance 37 -24** approving supplemental appropriations in the 2024 budget of \$30,000 Jeffrey Summer Camp S&W (05-580-51010), \$10,000 Before/After Care S&W (05-526-51010), \$14,000 Recreation Professionals (05-520-51710), and \$4,000 Recreation Special Activities (05-520-51321) to pay the additional costs associated with an increase in programming, introduced by Jess Saad on October 22, 2024.

Mr. Fishel read the ordinance and Ms. Saad provided a brief overview and background.

- d) **Ordinance 38-24** to Establish the Water and Sewer Rates charged by the City of Bexley, introduced by Jess Saad on October 22, 2024.

Mr. Fishel read the ordinance and Ms. Saad provided a brief overview and background.

- e) **Ordinance 39-24** to establish compensation rates for non-bargaining unit employees of the City of Bexley, effective as of January 1, 2025, introduced by Jess Saad on October 22, 2024.

- f) **Resolution 10-24** confirming the Mayor's appointments of members to the Community Improvement Corporation Board, introduced by Danny Hurley on October 22, 2024.

Mr. Fishel read the Resolution and Mr. Hurley and Mayor Kessler provided some background and information on this Resolution.
