b. Other

Ms. Barb Giller shared with the Tree Commission that Bexley in Bloom has collected to date over \$10,000.00 from 96 donations. This is on target from last year.

The Bexley Beautification fund will be meeting June 10, 2019 to review any grant request.

Mr. Larry Helman wanted to discuss the street trees along E. Broad and if the Tree Commission selected the right tree for the area. A discussion was held among the commission regarding the topic.

2. Applications to be reviewed -

a. 2399 South Commonwealth Park

Ms Elena Andrews presented her staff review for 2399 S Commonwealth Park. The resident is proposing planting in the right of way along S Drexel ave. The plant material fits in well for the area and is varied in height. The proposed shrubs are 18-24 inches.

Mr. Joe Doble with Garden Design LLC presented the landscape plan before the Tree Commission. The goal for the design is to add screening for the residents and add screening for the tennis court. Any noxious weeds will be removed and replaced with the proposed plant material. To have year round screening, evergreens are being proposed. The proposed plant material will also have an irrigation system and will be properly pruned to maintain any line of sight issues and will be clear of the sidewalk for pedestrian traffic. The proposed fence will be historically accurate to the home. Research was done so the fence will match architectural design elements of the home.

The proposed material for the fence is cedar. They would like to install landscape as soon as possible.

A discussion was held regarding the maintenance of the plant material among the Tree Commission. The applicant assured the Commission that the sidewalk will be clear and the plant material will be maintained.

b. Blue Spot Yoga

Ms. Elena Andrews presented her staff report for 396 N Cassady - Blue Spot Yoga to the Tree Commission. The landscape will take place along Cassady and Ruhl. Ms. Elena Andrews suggested to the Tree Commission they exclude the patio design for any approval and table for any future review.

The landscape plan was presented by Mr. Joaquin Serantes. The goal for the landscape plan is to bring all the elements of the building and parking lot together. The parking lot will remain as is. The curb cuts will be removed by the city along Ruhl Ave. Proposed landscape along Cassady Ave will include low shrubs to conceal low concrete

pedestal that are currently in place for the lighting system. 20 taxus plants are proposed to be planted along Cassady Ave and 50 of the taxus plants will be planted along Ruhl Ave. AEP has boxes along Cassady Ave and they will not be concealed by plant material, there is not enough room in front of the boxes for plant material. Ms. Linda Zupnick asked if there are guarantees for any proposed plant material, to which, Mr. Joaquin Serantes responded that the plants will be 24 inches at center and 24 inches tall. The trees will be 3 inches in calipers. There is no proposed plan to irrigate the site.

Mr. Chuck, an electrical coordinator from Smith Handy, came forward to share with the Tree Commission about the plans for up-lighting the signage for Blue Spot Yoga. One existing concrete pedestal will be removed as it serves no purpose. Mr. Chuck is unsure of another existing concrete pedestal and its uses. 4 lights are proposed to be removed and replaced with black poles and square LED heads.

A discussion was held among the Tree Commission regarding the lighting in the parking lot, curb cut removal, and the patio.

- 2. Follow up with staff review and approval of the location and final selection of the parking lot lights and lighting for sign.
- 3. Follow up with staff review and approval of final parking lot layout.
- 4. Patio adjacent to building omitted from approval. Patio design will need to be brought forward to the Tree Commission for approval prior to future installation.
- 5. All plant material will be reviewed annually, Any dead or inviable plant material will need to be replaced.' Motion seconded by Sheila Straub. **Vote 7 0 passed.**

c. 280 South Columbia

Ms. Elena Andrews presented her staff report for the new build located at 280 S. Columbia. The documentation Ms. Elena Andrews asked for was provided and the overall proposed landscape design is appropriate for the site. There were some shrubs that were removed along Columbia in order to gain access to the sewer lines. Some damage was done to two existing trees which are proposed to be removed, which

include, an Ash tree located closer to the street, and an Oak tree. 4 new horn beams have been proposed for planting in the center, 3 Kousa Dogwoods have been proposed, and 1 Redbud proposed to the overall landscape plan.

Due to the poor condition of the site, the Building Department issued a stop work order on the site and work was not permitted for about 1 week until the condition of the site was appropriate. The City Arborist, Mr. Grant Archer, has been on site and working with contractors to make sure the existing trees have the proper protection plan in place.

The landscape plan was presented by Mr. Kevin Fallona from Ciminello's Inc. Mr. Kevin Fallona is proposing the removal of 4 trees. The existing Ash tree and Oak tree will affect the proposed turn around driveway. A smaller existing tree is located in the middle of the proposed driveway. The last existing tree is located on the corner and the tree is dying and being removed for any safety concerns. The existing brick curb at the approach have been removed, however, the bricks have been saved and will be replaced. Mr. Larry Helman shared his thoughts regarding a change of the new home. What was once a backyard and screened in one way is now front yard and believes the applicant should have the right to have a front lawn that goes all the way to the sidewalk. A discussion was held among the Tree Commission regarding the landscape design.

d. CoGo Bike Share - Clifton Avenue

Ms. Elena Andrews presented the landscape plan for the CoGO bike share stations located along Clifton Ave. The CoGo bikes stations within Bexley are out performing those stations in Upper Arlington. The goal for the plant material is to be simple and low maintenance. A 4 foot bed will be added around the perimeter of the bike station. 3 Taxus are being proposed at each end. Behind the bike station proposed plant material include Ninebark, Fine line Buckthorn, and Yew all of which are hardy plants. The proposed plants will be alternating and will add some screening while maintaining a line of sight.

Mr. Bill Dorman shared with the Tree Commission that per contract CoGo must always have bikes at each station. He also shared that the placement of the bike stations are not permanent and can be moved, if needed.
