

REQUEST FOR PROPOSALS

SEWER SYSTEM ANALYSIS AND CAPITAL IMPROVEMENT PLANNING

BACKGROUND

The City of Bexley, Ohio invites proposals from qualified engineering firms to conduct a thorough analysis of the City's sanitary and storm sewer systems. The qualified firm will use this analysis to develop a 10-year capital improvement plan to enhance the infrastructure's capacity, integrity, and resilience against inflow and infiltration, and sanitary sewer backups.

SCOPE OF WORK

The selected firm will provide comprehensive engineering services, including but not limited to:

- **Analysis Lookback**: Summary of existing data and studies, and analysis of what areas of the system warrant further investigation to ensure an accurate and full understanding of conditions and maintenance priorities system-wide. The successful firm will be provided with full access to all existing data and past studies.
- **Past Improvement Evaluation**: Summary of improvements made since 2014, as well as an analysis of the successes or failures of those improvements. The successful firm will be provided with information regarding past improvements and will have access to the City's contracted City Engineer and Public Service Department personnel for background as needed.
- **Comprehensive System Evaluation**: Detailed assessment of the existing sanitary and storm sewer systems to identify current capacities (size), structural integrity (type, age and condition) and areas susceptible to inflow and infiltration. Evaluation should be inclusive of publicly owned infrastructure in addition to residential laterals, considering their overall impact on the integrity of the system.
- **Risk Assessment:** Identification of vulnerabilities and potential failure points that could impact the system's effectiveness in preventing flooding and sanitary backups, and ensuring safety.
- **Improvement Plan:** Development of a prioritized 10-year capital improvement plan addressing the urgent and long-term needs of the sewer systems.
- **On-Going Analysis and Policy Recommendations:** Suggest policy updates to improve ongoing system analysis, maintenance practices and regulatory compliance.

PROPOSAL REQUIREMENTS

Proposals should include the following components:

- Firm Overview: History, structure, and previous experience in similar infrastructure analysis projects.
- **Approach and Methodology:** Description of proposed methods for system analysis, risk assessment, and development of the improvement plan.
- **Project Management Strategy:** Outline of the project management approach, including timeline, milestones, and reporting

- **Team Composition:** Qualifications and experience of the lead project manager and key personnel. Identification of all subcontractors to be engaged, detailing their individual scopes and responsibilities, as well as compensation.
- **Project Budget Estimate:** Comprehensive line-item budget, detailing all anticipated costs such as labor, materials, and any subcontracted services.

EVALUATION CRITERIA

Proposals will be evaluated on the following basis:

- Expertise and Experience: Prior experience with municipal sewer systems and similar projects.
- Technical Approach: Adequacy, innovation, and feasibility of the technical approach.
- **Project Team and Management Plan:** Qualifications of the project team and effectiveness of the management plan.
- **Cost:** Cost-effectiveness of the proposal in providing value to the City.
