#### 10. Administrative Update

#### a) Mayor's Update

Mayor Kessler didn't have any additions to his report. Ms. Feibel asked about the Green Bexley Recycle and DEI Takeback day. Mr. McPeek also thanked Mayor Kessler for his work on the EV Chargers and Mayor Kessler acknowledged Ms. Meyer's hard work on that. He also acknowledged the work of the Finance Team.

## b) Finance Department, Karrie Martin

Ms. Martin shared that income tax is up above projections and offered to answer any questions.

## c) Development & Administration Department, Megan Meyer

Ms. Meyer spoke about the newsletter that should be arriving soon. Mayor Kessler also complimented Ms. Meyer for her work on State of the Community. Mr. McPeek also thanked Ms. Meyer for the annual reports, which he complimented. Ms. Lampke thanked Ms. Meyer for his additional work.

#### d) Service Department, Andy Bashore

Mr. Bashore spoke briefly about the Columbia preconstruction meeting, sharing that he anticipated this project to be ramping up in mid-April. Ms. Feibel asked about trees coming down on Parkview and Mr. Bashore shared that replacements are likely in the fall, but we can follow up with Mr. Archer if he likes. Mr. Hurley asked about the sweet gum trees which have a lot of tree waste and whether the City is removing them. Mayor Kessler did share there is a form online.

## 11. Consent Agenda (No Speaker Slip Required)

a) Meeting Minutes from March 11, 2025

Ms. Lampke moved to adopt the Consent Agenda.

#### 12. Third Readings (No Speaker Slip Required)

a. Ordinance 07-25 to Create Chapter 1473, Maintenance of Elevators, requiring landlords who rent residential units with access to an operational passenger elevator to keep the elevator maintained and operational for the duration of the rental term, introduced by Sam Marcellino on February 25, 2025.

Mr. Humphrey read the ordinance and Mr. Marcellino provided some background on the ordinance. Mr. Hurley asked about the role this ordinance would play in ADA compliance, and Mr. Marcellino shared that he feels it would depend on circumstances.

Mr. Marcellino moved to approve Ordinance 07-25.

Mr. Arthur Ruberg of 505 S. Parkview Avenue shared his appreciation for the ordinance, and spoke about his experiences as a disabled person in a building that has experienced elevator issues.

Mr. Hurley seconded.

 Resolution 01-25 to support the ongoing investment in the repair and replacement of sewer infrastructure, and to support the planned refresh of the City's sewer study and sewer plan, introduced by Jess Saad on February 25, 2025.

Mr. Humphrey read the ordinance and Ms. Saad provided some of the background on this ordinance. Mr. Markham asked about the resolution and then shared his intent to vote no on this resolution expressing concerns with the recommendation from City Staff to pursue the highest id. He went on to express

other concerns with the resolution. Mr. Marcellino also asked about the process of vendor selection and how we landed on making the choice for the most expensive bid, and Ms. Meyer shared some of the rationale behind the selection process. Mayor Kessler clarified that this Resolution does not determine vendors, but rather support for the study as a whole.

Mr. Silverman shared some confusion about the email that was sent to Council today related to this Resolution and questions that had been submitted anonymously. Ms. Saad and Ms. Feibel spoke in support of this resolution, expressing support of the staff's opinions and work on this Mr. Marcellino then shared his confidence in Mayor Kessler and his staff, but expressed concerns about responding to the necessity of selecting the highest bid. Council continued to discuss this resolution and matter for some time. When Council conversation concluded and hearing no further Council questions, Ms. Lampke opened the ordinance to the public for comment.

Ms. Constance Lewis of 663 Euclaire Avenue shared her concerns with the high cost of the recommended study.

Ms. Saad moved to Table Resolution 01-25.

Mr. Silverman seconded.

#### BEXLEY CITY COUNCIL POLICY FOR PUBLIC COMMENTS

For the purpose of receiving comments from all speakers desiring to offer comments at City Council meetings, Council adopts the following policy:

- Speaker Slips are not required if you wish to comment on the Consent Agenda, at the Third Reading, or on a motion to adopt. Speaker Slips are required at all other times.
- If a Speaker Slip is Required, any speaker wishing to address Council shall complete a Speaker Slip and turn it in to the Clerk of Council or the City's Executive Assistant prior to the start of the meeting or during the designated agenda item requesting Speaker Slips be turned in. Such Speaker Slip must include the speaker's legal name, address, email address and phone number.
- All speakers must share their legal name/address when offering public comments.
- All public comments should be directed to City Council and should pertain to City of Bexley business only and where applicable, to the relevant Ordinance/Resolution.
- Comments must be made within a maximum of five (5) minutes (this limitation is the same rule that applies to City Council members per 220.01 (rule 13).
- Please avoid offering points of view that have already been addressed by other speakers, if possible.
- Undue interruption or other interference with the order of business is not permitted.
- Comments that are abusive, disparaging, threatening, intimidating and/or are personal attacks are always out of order.
- Violation of this policy may result in termination of the speaker's comments and/or removal from the meeting.
- Council President reserves the right to limit the length/scope of Public Comments.
- You are also encouraged to email City Council Members(citycouncil@bexley.org) if you'd prefer.
