

# **City Council Minutes**

## Tuesday, September 9, 2025

#### 1. Call to Order

Ms. Lampke called the meeting to order at 6:03 pm.

#### 2. Roll Call of Members

Mayor Kessler honored Pelotonia Kids participants with a proclamation honoring their work.

Though the guests had not arrived, Mayor Kessler then read the proclamation honoring Childhood Cancer Awareness Month.

#### c. Mike Klapper & Julie Cohen, Columbus JCC

Ms. Saad then welcomed Mr. Klapper and Ms. Cohen with the JCC to share about the capital campaign and the exciting developments coming to the JCC. Mr. Klapper and Ms. Cohen shared some information about their project. Mr. Silverman asked questions and Mr. Marcellino thanked Mr. Klapper and Ms. Cohen for all they do for the community.

## 5. Guest Presentations

# a. Burgess and Niple - Update on Flow Monitoring

Ms. Lampke then moved on to invite Mayor Kessler to introduce the flow monitoring team and presentations. Mayor Kessler turned this over to Ms. Meyer who introduced Mr. Koch and Mr.

Salmons. She then provided some background to the purpose of the flow monitoring and the types of data captured. Mr. Swartzbough presented a presentation on the flow monitoring study completed on the sewers and some of the major conclusions of the data. Multiple Council Members asked questions and expressed concerns about the study, the data, and next steps. The representatives, Ms. Meyer, and Mayor Kessler answered questions from multiple Council members and Mr. McPeek.

#### 6. Tabled Ordinances

Ordinance 15-25 to amend the Codified Ordinances to permit Accessory
 Dwelling Units under specified conditions, and to enact new Sections 1266.24,
 1290.01, and 1290.02 of the Codified Ordinances, introduced by Sam Marcellino
 on May 27, 2025. (tabled on June 24, 2025)

Mr. Marcellino moved to remove Ordinance 15-25 from the table.

Mr. Hurley seconded.

Motion passed 7-0.

Mr. Marcellino discussed the background of this ordinance and shared about the work he's done to connect with others throughout the community and the larger Central Ohio region to discuss this initiative. He then shared his belief in the positive impact of this ordinance.

Mayor Kessler shared about the recent BZAP meeting to discuss this ordinance, inviting Mr. Klingler to add some information on some of the changes recommended by BZAP at today's conditional recommendation to adopt the ordinance. The conditional recommendations include a registration requirement, a minimum-time-of-residency condition, and a potential change to the residency limit maximum. Mayor Kessler then went over the changes to the language, which do not include any changes to the number of persons allowable. Mr. Marcellino asked some questions about parking, which Mr. Markham echoed. Mayor Kessler answered those. Ms. Saad asked clarifying questions on language which Mr. Marcellino and Mayor Kessler answered. Mr. Markham asked a question about the maximum number of allowable ADUs, which Mr. Marcellino explained. Mr. Hurley spoke to his thoughts on the maximum number, which he feels will self control to some extent. Mayor Kessler and Mr. Klingler both provided some information to share the number of accessory units in Bexler the past year. Mr. Markham complimented the structure of this process and work that's been taken to triple check this ordinance.

Mr. Marcellino moved to amend the ADU ordinance

Mr. Markham seconded.

Mr. Marcellino moved to approve Amended Ordinance 15-25.

Ms. Feibel shared her appreciation for the process, and shared her feelings in the importance of having the ability to take care of aging family members, also spoke about the work she does with Families Flourish, and agreed with the slow approach.

Mr. Silverman echoed the thoughts in support of the ordinance.

Ms. Saad shared the background of the ordinance and the steps Councilman Marcellino and Council as a whole have taken.

Ms. Lampke also shared her support of this ordinance before opening the meeting up to public comment.

Ms. Amy Klaben from Families Flourish spoke in support of the ordinance, sharing some suggestions as the City moves forward.

Mr. Vincent Coleman of Columbus Realtors spoke in support of the ordinance, but did share some concerns about the owner occupancy requirements.

Mr. of the Bexley Eastmoor Civic Association shared his support and excitement about seeing young adults and children having the opportunity to access Bexley's many amenities.

Ms. Saad shared about her change of heart over the long process, speaking to her appreciation for the changes and refinements that brought this ordinance to a place where she's comfortable voting yes..

Hearing no more comment, Ms. Lampke invited Mr. McPeek to call the vote.

Mr. Klingler added some details on the Schneider Bridge going out to bid and shared that the Fitzgerald exterior is coming together now. Mr. Silverman thanked Mr. Klingler for his work toward improvement in his department. Mr. Marcellino also added his interest in adding staff to the Building Department to support this work.

**c. Resolution 07-25** adopting the City of Bexley 2025 Land Use Strategy, introduced by Danny Hurley on September 9, 2025.

Mr. Fishel read the ordinance and Ms. Lampke provided some brief background before inviting Mayor Kessler to share more. Mayor Kessler complimented Ms. Meyer on her hard work on this document and together they briefly discussed the format of the document, encouraging Council to review it in more detail.

#### **BEXLEY CITY COUNCIL POLICY FOR PUBLIC COMMENTS**

For the purpose of receiving comments from all speakers desiring to offer comments at City Council meetings, Council adopts the following policy:

- Speaker Slips are not required if you wish to comment on the Consent Agenda, at the Third Reading, or on a motion to adopt. Speaker Slips are required at all other times.
- If a Speaker Slip is Required, any speaker wishing to address Council shall complete a Speaker Slip and turn it in to the Clerk of Council or the City's Executive Assistant prior to the start of the meeting or during the designated agenda item requesting Speaker Slips be turned in. Such Speaker Slip must include the speaker's legal name, address, email address and phone number.
- All speakers must share their legal name/address when offering public comments.
- All public comments should be directed to City Council and should pertain to City of Bexley business only and where applicable, to the relevant Ordinance/Resolution.
- Comments must be made within a maximum of five (5) minutes (this limitation is the same rule that applies to City Council members per 220.01 (rule 13).
- Please avoid offering points of view that have already been addressed by other speakers, if possible.
- Undue interruption or other interference with the order of business is not permitted.
- Comments that are abusive, disparaging, threatening, intimidating and/or are personal attacks are always out of order.
- Violation of this policy may result in termination of the speaker's comments and/or removal from the meeting.
- Council President reserves the right to limit the length/scope of Public Comments.
- You are also encouraged to email City Council Members(citycouncil@bexley.org) if you'd prefer.
