They want the sculpture to be displayed among tiered gardens, providing seasonal color and interest and an ambiance in spirit of the sculpture. The courtyard is to be enclosed and screened from Stanbery Ave to provide privacy between the street and the courtyard. The privacy plantings for the courtyard are located within the city Right of Way, in line with and to the inside of the canopy of the existing mature trees that are planted in the City's Right of Way.

A revised front walkway entrance is also desired so that when cars are parked in the driveway, visitors may comfortably access the front door.
