**Tuesday, October 14, 2025**

### **1. Call to Order**

Ms. Lampke called the meeting to order at 6:04 pm.

### **2. Roll Call of Members**

Council Members in Attendance: Danny Hurley, Lori Ann Feibel, Sam Marcellino, Troy Markham, Jess Saad, Monique Lampke

Ms. Lampke moved to excuse Mr. Silverman.

Mr. Marcellino seconded.

## **8. Administrative Update**

### **a. Mayor's Update**

Mayor Kessler first invited Officer Spradlin to introduce herself. She did so and Chief Lewis also spoke about her background.

Mayor Kessler spoke about the potential move of the Fourth of July fireworks to the same night as Red, White, and Boom. For the coming year, this would mean Friday, July 3 for fireworks with the parade to take place the following morning. This change would bring Bexley's celebrations in line with other local communities on the east side, who are all currently scheduled to coincide with Red, White, and Boom.

Mayor Kessler also shared some additional security concerns that prompted a revisit to the holiday schedule. Chief Lewis shared some additional details on the security concerns, citing crowd control concerns with having such high numbers of attendees. Ms. Feibel shared her belief that we should support the police, then asking Chief Lewis if moving the date would be enough to quell these concerns. Chief Lewis shared his belief that our celebrations being the only option on the Fourth played a significant role in the large crowd size. Mr. Hurley asked about moving back the start time of the parade, which Mayor Kessler shared he'd consider, but did cite issues with heat given the length of our parade. Ms. Lampke asked about where additional support might come from if other communities are also working their events, which Chief Lewis answered, sharing it is a challenge given the additional strain the holiday places on officers throughout the region.

### **b. Chief Gary Lewis, Police Department**

Chief Lewis did not have any additions to his report. Ms. Saad complimented his staff on continued community outreach. Ms. Saad asked about Officer Grimes and some of the work he's doing at St. Charles, which Chief Lewis answered.

Mr. Humphrey read Resolution 07-25 and Mr. Hurley also spoke about the document and his interest in voting tonight after a presentation. Ms. Meyer led Council through the document, highlighting some of the possibilities presented in the opportunity sites throughout the document. Mr. Marcellino asked about the missing pages, which Ms. Meyer and Mayor Kessler shared are likely being removed due to them involving a school property and the schools being in the midst of a facilities plan. Ms. Feibel, Ms. Lampke, and Ms. Saad all shared their compliments and enthusiasm for this new plan and document.

Ms. Saad did ask about how to obtain the Trail Town designation, which Mayor Kessler answered is being pursued. Mr. Markham also complimented the process and the document. Mr. Hurley asked when they'd anticipate having the final document. Mr. Marcellino requested holding off on a vote until it's ready. Mayor Kessler then shared his belief in the importance of the Land Use Strategy being a working document that inspires progress and projects and that he has and will continue to take the Land Use Strategy very seriously.

Mr. Hurley moved to table the Resolution 07-25.

## **BEXLEY CITY COUNCIL POLICY FOR PUBLIC COMMENTS**

For the purpose of receiving comments from all speakers desiring to offer comments at City Council meetings, Council adopts the following policy:

- Speaker Slips are not required if you wish to comment on the Consent Agenda, at the Third Reading, or on a motion to adopt. Speaker Slips are required at all other times.
- If a Speaker Slip is Required, any speaker wishing to address Council shall complete a Speaker Slip and turn it in to the Clerk of Council or the City's Executive Assistant prior to the start of the meeting or during the designated agenda item requesting Speaker Slips be turned in. Such Speaker Slip must include the speaker's legal name, address, email address and phone number.
- All speakers must share their legal name/address when offering public comments.
- All public comments should be directed to City Council and should pertain to City of Bexley business only and where applicable, to the relevant Ordinance/Resolution.
- Comments must be made within a maximum of five (5) minutes (this limitation is the same rule that applies to City Council members per 220.01 (rule 13)).
- Please avoid offering points of view that have already been addressed by other speakers, if possible.
- Undue interruption or other interference with the order of business is not permitted.
- Comments that are abusive, disparaging, threatening, intimidating and/or are personal attacks are always out of order.
- Violation of this policy may result in termination of the speaker's comments and/or removal from the meeting.
- Council President reserves the right to limit the length/scope of Public Comments.
- You are also encouraged to email City Council Members([citycouncil@bexley.org](mailto:citycouncil@bexley.org)) if you'd prefer.
