On September 4th, 2020 I inspected the roof at 2702 Bellwood Ave. The current roof material is Pennsylvania black slates. These type of slates have a life expectancy of 90-110 years. The vast majority of the slates on the roof have reached the end of their service life. We strive to preserve any slate roof, however, sometimes the roof becomes unrepairable. It's my suggestion that the slates be removed and a new 30 year asphalt roof be installed with new flashings. Any rotted wood will be replaced with new deck boards.
