PROJECT SUMMARY

Project Description

The project consists of a 3 story, 11,500 square foot building on a .87 acre site. Vehicular egress is provided by a 2-way access from Parkview Avenue. There are approximately 34 surface parking spaces located to the north of the building. Where the building does not screen the parking lot, plantings will be provided. The one-lane drive-thru is located on the north of the building and accommodates a teller window, ATM and night deposit box. Pedestrians may enter the building from the sidewalk from East Main Street or from the north entrance adjacent to the parking area.

The architecture is simple and modern with brick and glass. The exterior façade includes of an all-glass first floor with a clear charcoal gray anodized aluminum storefront system. At the second and third floors, a rhythmic pattern of white brick panels and aluminum storefront panels wraps the west, south and east elevations. The same brick veneer on the north façade conceals the secure counting room and teller area while accommodating the night drop off, and ATM and limiting the view of the drive thru lane from inside the bank. The three-story bank lobby to the east is defined by a clear anodized curtainwall system with projecting architectural fins elevated above the first floor. Ipe wood panels mark both the south and north entries.




Level 1 Floor Plan









South Elevation




