Frieze board to be smaller crown moulding to match existing. Gutters to be half-round w/ circular downspouts to match existing.</p> <p>③ Not used.</p>	<p>④ Roofing to consist of slate shingles to match existing house.</p> <p>⑤ Stone veneer: Ohio Limestone & mortar to match existing house.</p> <p>⑥ Concrete step; 12" tread, 8" rise.</p> <p>⑦ New custom overhang with salvaged slate roof. Plywood soffit at ceiling. Brackets to match existing (that are being removed).</p>
