



## **City Council Meeting Minutes**

**Tuesday, January 25, 2022**

**6:00 PM**

**1) Call to Order**

President Markham called the meeting to order at 6:01pm.

**2) Roll Call of Members**

**4) Presentations/Special Guests**

**A) ESAC / Board of Health Mosquito Pilot Group Program Presentation**

Rebecca Ness, of the Bexley Mosquito Task Force, along with Dr. Megan Meuti and Dr. Mary Gardiner with the Entomology Department of OSU presented the attached PDF regarding the Mosquito Task Force.

Mr. Marcellino asked about the outcome and findings of similar studies and programs and what the results were on these, which Dr. Gardiner answered. Mr. Marcellino then asked a follow up question about the traps. Mr. Klingler asked about the location of the traps, which Dr. Meuti answered. Mr. Klingler then asked a follow up question about the number of tests. Ms. Feibel asked if the presence of traps would attract mosquitoes, and also asked about whether other communities have prohibited commercial spraying on private properties. Dr. Meuti answered the first question, and Dr. Gardiner responded to the second. Mr. Kessler added some information regarding households in Bexley that are currently opting out of mosquito treatment. Ms. Saad asked a follow-up question and Sarah with Franklin County Public Health will provide some additional information. Ms. Robinson and Mr. Markham offered some concluding thoughts and thanks.

Mr. Markham mentioned a certified letter received from Community Builders informing the City of interest in a development. Mr. Kessler expressed his thanks to snow plow crews.

Mr. McPeck had no specific report but did add his thanks to several individuals for their assistance and time in meetings.

**A) Service Department Update - Andy Bashore**

Mr. Bashore had no additions to his report. Mr. Kessler expressed his thanks for the work of the snow plow crews.

**B) Police Department Update - Interim Chief Gough**

Captain Gough had no additions to his report. Ms. Saad asked the captain to pass along her thanks.

**C) Recreation and Parks Update - Mike Price**

Mr. Price had nothing to add to his written report. Mr. Kessler complimented Mr. Price on the ice rink. Ms. Lampke thanked Mr. Price for offering a tour of the facility on 420 North Cassady. Ms. Saad also acknowledged an upcoming volunteer award and asked Mr. Price for a bit more information, which he offered.

**D) Finance Department Update - Beecher Hale**

Mr. Hale covered the highlights of the year end report and some of the items which differed from the City budget, providing some additional detail on these items.

**E) Mayor's Update**

Mr. Kessler then provided an update on the Drexel traffic plan, which will be discussed more in depth at the next Council meeting. Mr. Kessler clarified that he'd like to get clear and honest feedback from Council on this plan. There will be another public workshop on February 8, and Ms. Saad asked for clarification that a meeting notice would go out about this to adjacent residents, which Mr. Kessler confirmed. A brief conversation followed with Mr. Klingler, Ms. Saad, Mr. Kessler, and Mr. Marcellino all adding comment or questions.

Mr. Kessler also provided a Livingston Avenue update and reminded residents that the posters for this workshop are still available in the lobby for resident feedback. Ms. Robinson asked how long those will be open and Mr. Kessler confirmed the posters will be up through next week at least.


