4th of July Meeting

Join planners from Bexley's 4th of July activities to discuss proposed changes to the protocol for when the 4th of July falls on a Saturday or a Sunday. Specifically, we'll be discussing how to provide equal consideration to religious observance occurring on both days, while accommodating community celebration of the 4th. The proposal that is being discussed is to hold 4th of July celebrations on the day of the 4th, regardless of what day of the week it falls on. Past practice is to hold the celebration on the day of the 4th unless it falls on a Sunday, in which case it has in the past been moved to the 5th. 4th of July parade and evening activity organizers will also be on hand to answer questions about the 4th celebrations, take any suggestions, and let you know how you can help out!

Bexley History Briefing: Ferndale-Mayfield Landfill

A slice of Bexley history from Bexley Schools faculty Dr. Scott King-Owen's research into the former landfill:

Minard Holtzman, grandson of the founder of the Holtzman Piano factory on Main (where Kroger is now), owned the dump in the 1920s and 1930s. The village of Bexley cited him for maintaining a nuisance on the property and he protested in 1929 that the property belonged to him, so he could do with it as he pleased. He was then sued by Bexley residents for burning trash on the property and cited by the common pleas court for contempt of an injunction to stop. According to the case, citizens complained that he was burning "old automobile bodies" and other refuse. Holtzman claimed that he had acquired slate to use as fill but that the slate spontaneously combusted and he could not put out the fire.
