#### Renewable Community Choice Aggregation RFP Update


RFP is ready to be distributed tomorrow and will be open through March 5th. Final(?) RFP attached.


#### **RPACE** Update

#### Commonwealth West Arboretum feature planning update


Design committee has been meeting to hone a draft proposal to go to Rec Board and TPGC for review. Once through those review processes, will bring to council for review prior to working on funding.






# Havenwood Park landscape plan update
