An Ordinance No 29 to lay a special
assessment upon each and every foot of the lots and lands fronting

Be it ordained by the Council of the Village of Buxley, State of
Ohio, as follows:

Section 1. That in order to defray the cost and expense of improv-
ing Pleasant Ridge Avenue from Mound Street to
the ~~South~~^{North} side of Knobs-Rue Avenue in said village
(by grading and leveling the roadway and constructing a tile drain)
amounting to the sum of \$4500.00 that a special assess-
ment of $2\frac{1}{2}$ Cents per front foot be and is hereby
levied and imposed upon each and every front foot
of the lots and lands bounding and abutting upon said
Pleasant Ridge Avenue between Mound Street and Knobs
Rue Avenue: Said special assessment in the opinion
of the Council not being in excess of the special benefit
to said lots and lands resulting to them in consequence
of said improvement.
