ORDINANCE NO. 55

GRANTING THE FORREST REALTY COMPANY THE RIGHT TO CONSTRUCT SEWERS IN THE VILLAGE OF BEXLEY.

Whereas, the Forsest Realty Company is the owner of "Bexley Park Addition" to the Village of Bexley, and

Whereas, a part of said addition lies within the corporate limits of said Village, and

Whereas, said Realty Company has caused plans for a system of sanitary sewers complete with manholes and other appurtenances to be prepared by A. Elliott Kimberly for said Bexley Park Addition, and

Whereas said system as planned conforms to the sewage system recently constructed by said Village and

Whereas said Realty Company desires permission to enter upon the streets, avenues and alleys of said Village for the purpose of constructing that portion of said sanitary sewer system lying within the corporate limits of said Village and when complete, to connect the same with the sewer system of said Village.

NOW THEREFORE, Be It Ordained by the council of the Village of Bexley, State of Onio as follows, to-wit:

SECTION 1. That The Forrest Realty Company be and hereby is granted the right and privilege to enter upon the streets and alleys of that part of said Bexley Park Addition lying within the corporate limits of said Village, and at its own cost and expense to construct therein that portion of the aforesaid sanitary system located within the corporate limits of said Village; and when said sewer system is completed, to connect the same with the sewer system of said Village.

SECTION 2. That said Sewer system shall be constructed in accordance with the plan, profiles and specifications therefor, prepared by A. Elliott Kimberly; and that said Realty Company shall save and keep said Village harmless from all claims and suits for damages by any person or persons, caused by or growing out of the work of constructing said sewers, and upon completion thereof shall restore said streets to their former condition of usefulness.

SECTION 3. That a copy of the plan, profiles and specifications

of said sewer system shall be filed with the Board of Trustees of Public Affairs of said Village and all persons desiring permission to top said sewers shall obtain a permit for that purpose from said Board of Trustees or other proper officers and shall be in all respects governed by the rules and regulations provided for the tapping and use of the sewers of said Village.

SECTION 4. This ordinance shall take effect and be in force upon the parliest date allowed by law after its passage.
