

RESOLUTION NO. 117

TO IMPROVE COLLEGE AVENUE FROM MAIN STREET TO LIVINGSTON AVENUE, AND TO REPEAL RESOLUTION NO. 112 ADOPTED MARCH 18, 1915.

RESOLVED, By the Council of the Village of Bexley, State of Ohio:

(a) That it is necessary to improve College Avenue from Main Street to Livingston Avenue of said Village by grading, curbing, paving the roadway with brick, concrete, some form of asphalt or some form of treated macadam, constructing the sewers necessary to furnish proper drainage for such improvement, and constructing water and sewer connections from the water main and sewer in said avenue to the inner line of the curbs on said avenue; in accordance with the plans, specifications, estimates and profiles of said proposed improvement prepared by the engineer of said Village, which plans are hereby approved:

(b) That the grade of said Avenue as improved shall be as shown on the plans and profiles towit:

WEST CURB - Beginning at intersection of the west curb of College Avenue with south line of Main Street at elevation 97.2 ft. Village datum; thence by a 0.5% ascending grade 50 ft. to a point at elevation 97.45 ft.; thence by an 0.3% descending grade 2950 ft. to a point at elevation 88.60ft.; thence by an 0.8% descending grade 368 ft. to the North Property Line of Livingston Avenue at elevation 85.66 ft.

EAST CURB - Beginning at the intersection of the East curb with the South line of Main Street at elevation 97.67 ft., Village datum; thence by an 0.44% descending grade 50 ft. to a point at elevation 97.45 ft. from which point the curb is same elevation as West curb to Livingston Avenue.

(c) That the whole cost of said improvement, less one-fiftieth thereof and the cost of intersections, shall be assessed in proportion to the special benefits which may result from the improvement upon the following described lots and lands, towit: All lots and lands bounding and abutting upon the proposed improvement, which said lots and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to the cost thereof.

(d) That the assessments so to be levied shall be paid in ten annual installments, with interest on deferred payments at a rate not exceeding six per cent per annum; provided that the owner of any property assessed may,

at any time after such assessment has been levied, with interest to the semi-annual interest day of said bonds next following date of payment;

(e) That bonds of said village of Bexley Ohio, shall be issued in anticipation of collection of the assessments by installments, and in an amount equal thereto;

(f) That the remainder of the entire cost of said improvement shall be paid by the issuance of bonds of the village in the manner provided by law.

(g) That Resolution No. 112 adopted March 18th 1915 and this same hereby is repealed. repealed
