ORDINANCE NO. 77

PROM MAIN STREET TO LIVINGSTON AVENUE, IN THE VILLAGE OF BEXLEY, OHIO.

BE IT ORDAINED by the Council of the Village of Bexley, State of Ohio:

prevenent of College Avenue from Main Street to Livingsten Avenue in said Village by grading, curbing, paving the readway with brack, concrete, some form of asphalt or come form of treated macadam, constructing the sewers necessary to furnish proper drainage for such imprevement and constructing water and sewer connections from the water main and sewer in said avenue to the inner line of the surbs on said avenue, in accordance with the resolution declaring it netpasary to impreve said avenue, adopted by the Council of said Village on the 22" day of April, 1915, and in accordance with the plans, specifications, estimates and prefiles of said proposed imprevement heretofore approved and now on file in the effice of the Clerk of said Village.

Section 2. That all claims for damages resulting therefrom shall be judicially inquired into after the completion of the proposed improvement and the Village Selicitor be and he hereby is authorised and directed to institute proceedings in a court of competent jurisdiction to inquire into such claims.

Section 3. That the whole cost of said improvement, tegether with the interest on bends issued in anticipation of the collection of assessments to be levied for said improvement and all other necessary expenditures, less one fiftieth (1/50) thereof and the cost of intersections, shall be assessed in propertion to the special benefits which may result from the improvement upon the following described lets and lands towit: All lets and lands fronting, bounding or abutting upon said improvement on said avenue between Main Street and Livingstom Avenue, which said lets and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to the cost thereof.

be and the same hereby is appropriated from the street improvement and intessection fund to pay the remainder and cost of said improvement.

Section 5. That the assessments so to be levied shall be paid in ten annual installments with interest on deferred payments at a rate not exceeding six per cent (6%) per annum; provided that the owner of any property assessed may, at his option, pay such assessments or any part of the installments thereof, at any time after said assessment has been levied, with interest to the semi-annual interest day of said bonds next following date of payment.

Section 6. That bonds of the Village of Bexley, Ohio, shall be issued in anticipation of the collection of assessments by installments, and in an amount equal thereto.

Section 7. That the Clerk of said Village be and he hereby is authorized and directed to advertise for bids for the construction of said improvement according to law.

Section 8. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
