## AN ORDINANCE NO. 123

To levy Special assessments for the improvement of Town Street from Parkview Avenue to Drexel Avenue by grading, curbing, paving the roadway, constructing the sewers necessary to furnish proper drainage for such improvement and constructing water and sewer connections from the water main and sewer in said Avenue; and to repeal Ordinance No. 96 adopted the 232 day of 1915.

Be it ordsined by the Council of the Village of Bexley, State of Ohio:-

expense of improving Town Street from Parkview Avenue to Drexel Avenue in said Village by grading, curbing, paving the readway with Asphalt, constructing sewers necessary to furnish proper drainage for such improvement and constructing water and sewer connections from the water main and sewer in said Avenue, to the inner line of the curbs on said Avenue as reported to Council on the Lot day of May 1916 by the Board heretofore appointed to estimate said assessment, be and the same is hereby adopted and that there be and hereby is levied and assessed upon the lots and lands hereinafter described the several amounts herein set forth.

It is hereby determined and declared that each of said lots and lands are specially benefited by said improvement in an amount equal to said assessment.

SECTION 2. That the total assessment shall be payable at the office of the Treasurer of the Village of Bexley, Ohio, within a period of thirty (30) days from the date of the final passage of this Ordinance, with interest at the rate of Five (5) Per Cent per annum from the 1st day of July, 1916, or, at the option of the owner, in ten annual installments with interest at the rate of Five (5) Per Cent per annum upon deferred payments, at the office of the Treasurer of Franklin County, Ohio, after the same has been certified to the County Auditor for collection in the manner provided by law. Said assessment, after being so certified, may be paid in full or any number of annual installments may be paid at any tax collection time, with interest on the same to the semi-annual interest day next ensuing: to wit, October first or April first. If said installments of said assessment are not paid when the same become due, a penalty will be imposed and collected as provided by law.

SECTION 3. That said assessment and all portions thereof when collected shall be paid into the Sinking Fund and shall be applied to the payment of the bonds issued for said improvement and the interest thereof as the same shall become due and to no other purpose whatsoever.

SECTION 4. That Ordinance No. 96, adopted on the 23 day of October 1915, "To levy special assessments for the improvement of Town Street from Parkview Avenue to Drexel Avenue, etc.", be and the same hereby is repealed.

SECTION 5. This ordinance shall take effect and be in force from and after the earliest period sllowed by
