AN ORDINANCE NO. 184

BY MR. Overman

TO APPROVE THE AMENDED PLAT OF THE EAST PART OF BLOCKS
14-15-16 and 17 of BULLITT PARK

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF
OHIO:

SECTION 1. That the Amended Plat of lots 1 to 5 and 14 to 15
in Block 14; 1 to 5 in Block 15; 1 to 5 in Block 16 and 1 to 5 in Block
17 of Bullitt Park Addition as the same is shown of record in Plat Book
4, page 416, Franklin County Plat Records, be and the same hereby is approv-
ed; and that all street and parts shown on said plat, not heretofore
dedicated to public use, hereby are accepted and the dedication thereof
to public use as highways hereby is confirmed.

SECTION 2. This ordinance shall take effect and be in force
from and after the earliest period allowed by law.

AN ORDINANCE NO. 184

BY MR. 

To levy special assessments for the improvement of Stanbery Avenue from the north line of Broad Street to the south line of Maryland Avenue, and to repeal ordinance No. 169, passed October 2nd, 1917.

SECTION 1. That to pay that portion of the cost and expenses hereto determined to be specially assessed for the improvement of Stanbery Avenue from the north line of Broad Street to the south line of Maryland Avenue, by grading, curbing and paving the roadway, constructing sewers necessary to furnish proper drainage for such improvement, and constructing water and sanitary sewer connections from the water main and sanitary sewer in said Avenue to the lots and lands fronting and abutting thereon, there be levied and assessed upon the lots and lands hereinafter described, the several amounts hereinafter set forth, to-wit;

which assessments are at the rate of \$9.58789 per front foot of the property assessed.

SECTION 2. That the total assessments shall be payable at the office of the treasurer of the village of Bexley, Ohio, within the period of thirty days from the date of the final passage of this ordinance, or at the option of the owner, in _____ with interest at the rate of five (5%) per cent. per annum semi-annually upon deferred payments, at the office of the treasurer of Franklin County, Ohio, after the same has been certified to the county auditor for collection in the manner provided by law. If said installments of said assessments are not paid when the same become due, a penalty will be imposed and collected, as provided by law.

SECTION 3. That said assessments and all portions thereof when collected shall be paid into the sinking fund and shall be applied to the payment of the bonds issued for said improvement and the interest thereon as the same shall become due, and to no other purpose whatsoever.

SECTION 4. That ordinance No. 169, passed October 2nd, 1917, entitled an ordinance "To levy special assessments for the improvement of Stanbery Avenue from the north line of Broad Street to the south line of Maryland Avenue," be and the same hereby is repealed.

SECTION 5. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
