

## Resolution #184.

A Resolution to borrow money in anticipation of the General Revenue Fund.

Resolved by the Council of the Village of Bexley State of Ohio, that it is necessary for the village to borrow the sum of \$5.00, for the period not to exceed sixty days, in anticipation of the general revenue fund of said village for the year of 1918.

Resolved, further, that the mayor and clerk of said village be and they are hereby authorized to borrow the sum of \$500. on behalf of the village for a period not exceeding sixty days, and a rate of interest not exceeding 6% per annum in anticipation of the general revenue of said village for the year 1918, and to issue certificates of indebtedness therefor duly signed by the mayor and clerk of the village and sealed with the seal thereof.


A Resolution to Borrow Money in Anticipation of

Resolved, Further, that the mayor and clerk of said Village be and hereby authorized to borrow the sum of \$1000.00 on behalf of the Village for a period not exceeding sixty days, and a rate of interest not exceeding 6% per annum in anticipation of the general revenue of said Village for the year 1918, and to issue certificates of indebtedness therefor duly signed by the mayor and clerk of the Village and sealed with the seal thereof.


