AN ORDINANCE NO. 186

BY MR. Hofmand

To levy special assessments for the improvement of Ashbourne Place in the village of Bexley, Ohio, and to repeal ordinance No. 170 passed October 2nd, 1917.

Be it ordained by the council of the village of Bexley, state of Ohio: SECTION 1. That to pay that portion of the cost and expenses hereto determined to be specially assessed for the improvement of Ashbourne Place in said Village by grading, curbing and paving the roadway, constructing sewers necessary to furnish proper drainage for such improvement, and constructing water and sanitary sewer connections from the water main and sanitary sewer in said Avenue to the lots and lands fronting and abutting thereon, there be levied and assessed upon the lots and lands hereinafter described, the several amounts hereinafter set forth, to-wit:

which assessments are at the rate of \$7.754 per front foot of the property assessed.

SECTION 2. That the total assessments shall be payable at the office of the treasurer of the village of Bexley, Ohio, within the period of thirty days from the date of the final passage of this ordinance, or at the option of the owner, in twenty annual installments with interest at the rate of five (5%) per cent. per annum, payable semi-annually upon deferred payments, at the office of the treasurer of Franklin County, Chio, after the same has been certified

to the county auditor for collection in the manner provided by law. If said installments of said assessments are not paid when the same become due, appealty will be imposed and collected, as provided by law.

SECTION 3. That said assessments and all pertiens thereof when collected shall be paid into the sinking fund and shall be applied to the payment of the bends issued for said improvement and the interest thereon as the same shall become due, and to no other purpose whatsoever.

SECTION 4. That ordinance No. 170, passed October 2nd, 1917, entitled an ordinance "To levy special assessments for the improvement of Ashbourne Place in the village of Bexley, Ohio," be and the same hereby is repealed.

SECTION 5. This ordinance shall take effect and be in force from and after the earliest period allowed by law.

AN ORDINANCE NO. 186

TO FIX THE LOCATION AND WIDTH AND ESTABLISH THE GRADE OF SIDEWALKS ON DREXEL AVENUE BETWEEN MAIN STREET AND BROAD STREET

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, STATE OF OHIO:

SECTION 1. That the sidewalks when constructed on Drexel
Avenue between Main Street and Broad Street in said village shall be not
less than five feet in width, with a cross slope of three-eights of an
inch per foot, and that the foot of the terrace slope shall not be less
than one foot from the inner edge of the walk.

SECTION 2. That said sidewalk shall be located as follows:

On the west side of the street from the north line of Main Street to a point opposite the center line of Fair Avenue the walk shall be placed with the inside edge one foot east of the lot line, from Fair Avenue it shall extend in a straight line to a point in the north line of Dale Avenue two feet east of the lot line and from the north line of Dale Avenue to the south line of Broad Street it shall be located with the inside edge two feet east of the lot line.

On the east side of the street the walk shall be located fut west of the lot line from the north line of Main Street to the south line of Sherwood Road. From the north line of Sherwood Road to the south line of Fair Avenue it shall be located 7 feet from the lot line. From the north line of Fair Avenue to the south line of Broad Street it shall be located two feet from the lot line.

SECTION 3. That the grade of the back or inside edge of the walk so located shall be as follows:

west Side: From the north line of Main Street to the south line of Dale Avenue the inside edge of the sidewalk shall be 5 inches above the curb and shall run parallel therewith. From the north line of Dale Avenue to the south line of Broad Street it shall be 8 inches above the curb and parallel therewith.

East Side: From the north line of Main Street to the south line of Sherwood Road the inside edge of the sidewalk shall be inches above the curb and parallel thereto. From the north line of Sherwood Road the elevation above the curb shall increase from 5 inches at Sherwood Road until at the south line of Bryden Road it shall be 12 inches above the curb from which point to the north line of Bexley Park Road it shall run 12 inches above and parallel with the curb. From the north line of Bexley Park Road the elevation above the curb shall decrease until at the south line of Brentwood Road it shall be 8 inches above the curb. From the south line of Brentwood Road to the south line of Broad Street the elevation shall be 8 inches above the curb and parallel thereto.

SECTION 4. This ordinance shall be in force from and after the earliest period allowed by law.
