

## Resolution 193. ✓

Declaring It Necessary to Improve Dawson Ave from Fair Ave to the Improved Roadway of Broad St.

Resolved By the Council of the Village of Bexley, state of Ohio, three-fourths of all members elected and appointed hereto concerning:

Section I That it is necessary to improve Dawson Ave from Fair Ave to the improved roadway of Broad St. in said village by grading, curbing, paving the roadway with brick, concrete, some form of asphalt or some form of treated macadam, constructing the sewers necessary to furnish proper drainage for such improvement, and constructing water and sewer connections from the water main and sanitary sewer in said Avenue to the inner line of the curbs on said avenue, in accordance with the plans, estimates and profiles of said proposed improvement prepared by the engineer of said village, which plans are hereby approved.

Section II That the grade of said Avenue as improved shall be as shown on the plans and profiles to-wit:

West Curb: Beginning at a point in the proposed east curb line of Dawson Ave 80 ft. north of the south line of Fair Ave, said beginning point being designated as Station 0 and having an elevation of 107.76 ft. Village Datum; thence from said beginning point northerly with an 0.40% ascending grade 200 ft. to Station 2, elevation 108.56 ft; thence on a minus 0.54% descending grade to Station 6 plus .05 elevation 106.35 ft; thence on a plus 0.30 ascending grade to Station 25 plus 60 at elevation 112.22 ft., same being the end of the improvement.

East Curb: Beginning at a point in the proposed east curb line of Dawson Ave 80 ft. north of the south line of Fair Ave, said beginning point being designated as Station 0 and having an elevation of 107.76 ft. Village Datum; thence from said beginning point northerly with an 0.40% ascending grade 200 ft. to Station 2, elevation 108.56 ft; thence on a minus 0.54% descending grade to Station 6 plus .05 elevation 106.35 ft; thence on a plus 0.30 ascending grade to Station 25 plus 60 at elevation 112.22 ft., same being the end of the improvement.

Section III That the whole cost of said improvement, less one-fiftieth thereof and the cost of intersections, shall be assessed

by the front foot upon the following described lots and lands, to-wit: All lots and lands bounding and abutting upon the proposed improvement, which said lots and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to the cost thereof.

Section IV: That the assessments so to be levied shall be paid in ten annual installments, with interest on deferred payments at a rate not exceeding six per cent per annum.

Section V: That the bonds of said Village of Bexley, Ohio, shall be issued in anticipation of collection of the assessments by installments, and in an amount equal thereto.

Section VI: That the remainder of the entire cost of said improvement shall be paid by the issuance of bonds of the village in the manner provided by law.
