

## Resolution No 171 ✓

Declaring It Necessary to Construct the Main Sewer  
In Sanitary Sewer District No 3.

Be It Resolved by the Council of the Village of Berley, State of Ohio, to-wit:

That it is necessary to construct a certain part of the sewers provided for in a general plan for a system of sewage for said village, which general plan was adopted by council on the 11th day of June, 1918, and is now on file in the office of the clerk of said village; & that the portion of the work provided for in said general plan which it is hereby determined to construct is as follows, to-wit. The sanitary main sewer shown upon the plan of said Sewer District No 3 commencing at the intersection of Livingston Ave + College Ave in said village; thence east in Livingston Ave to the first alley west of Euclaire Ave; thence north in said alley to Main St; thence continuing across Main St. + north in Cassidy Ave to Berley Ave; thence west in Berley Ave to Dawson Ave; thence north in Dawson Ave + Stanberry Ave to Maryland Ave. The boundaries of said Sewer District No. 3 are as follows:

Beginning at a point in the north corporation line of the Village of Berley where the same is intersected by the center line of Drexel Ave produced northerly, said beginning point being also in the south right-of-way line of the P.C.C. + St. L. R.R. + the B. + O. R.R. + being also at the northeast corner of Sanitary Sewer District No. 2 of the Village of Berley. O; thence from said beginning point easterly with the north corporation line of the Village of Berley + with the above mentioned right-of-way line to a point where the same is intersected by the center line of Spruce St. produced northerly; thence southerly with the center lines of Spruce St. + said center line produced, to a point in the present north line of Maryland Ave; thence easterly with said north line to a point where the same is intersected by the center line of Remington Rd. produced northerly; thence southerly with the center line of said Remington Rd. + with the center line of said road produced to a point in the north line of Fair Ave; thence easterly with the north line

of Fair Ave to a point in the east line of Belgard Lane produced; thence southerly with the east line of said Belgard Lane to a point in the south line of Main St; thence westerly with the south line of Main St. to a point in the center line of Reels Ave; thence southerly with the center line of said Avenue produced, to a point in the present south corporation line in the Village of Bexley; thence westerly with said south corporation line to a point where the same is intersected by a line parallel to Pleasant Ridge Ave. + 150 ft. east of the east line of same; thence northerly and parallel to Pleasant Ridge Ave + 150 ft. east of the east line of said Ave, to a point in the south line of Mound St; thence across Mound St. to a point in the north line of same 145 ft. east of the east line of Pleasant Ridge Ave; thence northerly parallel to Pleasant Ridge Ave. + 145 ft. east of same to a point in the south line of Main St; thence westerly with the south line of Main St. to a point where same is intersected by the west line produced, of the first alley east of Drexal Ave as the same is shown in Bexley Park Addition; thence northerly with the west line of said alley to a point in the south line of Fair Avenue 250 ft. east of the east line of Drexal Ave; thence 250 ft. east of and parallel to the east line of Drexal Ave to a point in the south line of lot 15 of Block 14, Bullitt Park Addition; thence westerly with the south line of said lot 15 to the southwest corner of same; thence northerly + northeasterly with the west line of lots 15 + 14 of said Block 14, Bullitt Park Addition, to a point in the south line of Broad St; thence northerly across East Broad St. to a point in the north line of same, which point is the southwest corner of Strawberry Place Addition; thence northwesterly, westerly and northerly with the west line of said addition to a point in the south line of Maryland Ave; thence westerly with the south line of said Avenue to a point in the same 250 ft. east of the east line of Columbia Ave; thence northerly 250 ft. east of and parallel to the east line of said Columbia Ave to a point in the south line of Caroline Ave; thence easterly with the south line of Caroline Ave to a

point in the center line of Drexel Ave; thence northerly with the center line of said Drexel Ave and the center line of same produced, to the place of beginning.

Be It Further Resolved, that said sewer shall be constructed in accordance with the plans, and specifications on file in the office of the clerk of said village and shall be of vitrified pipe, segment block pipe or concrete pipe.

Be It Further Resolved, that 85% of the whole cost of constructing said sewer shall be assessed in proportion to the benefits which may result from said improvement upon all the lots & lands within the boundaries of said Sewer District No 3, hereinbefore set forth & described, which said lots & lands are hereby determined to be specially benefited by said improvement; and the cost of said improvement shall include the expense of the preliminary and other surveys, and of printing & publishing notices, resolutions & ordinances required, the serving of such notices, the cost of construction, together with interest on bonds issued in anticipation of the collection of deferred assessments, and all other necessary expenditures.

Be It Resolved Further, that the clerk be and he is hereby directed to cause this resolution to be published in the manner provided by law.
