AN ORDINANCE NO. 211

BY MR. Ray

TO LEVY SPECIAL ASSESSMENTS FOR THE IMPROVEMENT OF BULLITT
PARK PLACE FROM THE NORTH LINE OF BEXLEY AVENUE TO THE
IMPROVED ROADWAY OF BROAD STREET

WHEREAS, an estimated assessment of the cost of improving said Bullitt
Park Place has been reported to this council by the board heretofore appointed
for that purpose; and

WHEREAS, all of the owners of the lots and lands fronting and abutting
upon said proposed improvement have filed with this council a waiver of the pub-
lication of the notice of said estimated assessment as required by Section 3895,
General Code, Now, Therefore,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BEXLEY, OHIO:

SECTION 1. That the assessment of the cost and expense of improving
Bullitt Park Place from the north line of Bexley Avenue to the improved roadway
of Broad Street in said village by grading, curbing, paving the roadway with
brick, concrete, some form of asphalt or some form of treated macadam, con-
structing sewers necessary to furnish proper drainage for such improvement, and
constructing water and water connections from the water main in said Bullitt
Park Place to the inner line of the curb on said improvement as reported to the
council on the _____ day of June, 1919, by the board heretofore appointed to
estimate said assessment, be and the same is hereby adopted, and that there be
and hereby is levied and assessed upon the lots and lands hereinafter des-
cribed the several amounts hereinafter set forth, viz.:

It is hereby determined and declared that each of said lots and lands are specially benefited by said improvement in an amount equal to said assessment.

SECTION 2. That the assessment against each lot or parcel of land shall be payable in ten annual installments at the office of the treasurer of Cuyahoga County, Ohio, with interest on the deferred payments at the rate of ~~10~~ per annum, payable semi-annually, after the same has been certified to the county auditor for collection in the manner provided by law. If said installments of said assessment are not paid when and as the same become due, a penalty will be imposed and collected as provided by law.

SECTION 3. That said assessment and all portions thereof when collected shall be paid into the Sinking Fund and shall be applied to the payment of the bonds issued for said improvement and the interest thereon as the same shall become due, and to no other purpose whatsoever.

SECTION 4. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
