TO PROVIDE FOR THE ISSUE OF BONDS IN ANTICIPATION OF THE COLLECTION OF SPECIAL ASSESSMENTS FOR THE IMPROVEMENT OF BULLITY PARK PLACE FROM THE NORTH LINE OF BEXLEY AVENUE TO THE IMPROVED ROADWAY OF BROAD STREET

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE of AXIEY, STATE OF OHIO, to-wit:

SECTION 1. That bonds of said village, shall be issued in the aggregate amount of \$10,000.00 for the purpose of raising money in anticipation of the collection of special assessments to pay for the improvement of Bullitt Park Place from the north line of Berley Avenue to the improved roadway of Broad Street in said village by grading, out it was a macadam, constructing the sewers necessary to furnish proper drainage for such improvement and constructing water and sewer cour actions from the water main and sanitary sewer in said Bullitt Park Place to two the curbs on said avenue in pursuance of Ordinance No.

100 , passed the 13th day of May, 1919.

shall bear of April first, 1919. They shall be of the denomination of \$900.00 each, numbered from one to see both inclusive, and be payable in the order of their number. One of said bonds shall become due and payable on the first day of April in each of the years 1920, to 1929 both inclusive. They shall bear interest at the rate of 5% per annum, payable semi-annually on the first day of April and October of each year, for which properinterest coupons, bearing a fac simile of the signature of the village clerk, shall be attached to and made a part of said bonds. Both principal and interest shall be payable set the office of the treasurer of said village.

SECTION 3. For the purpose of paying the interest on and providing a sinking fund for the final redemption of said bonds at maturity, the trustees of the sinking fund of said village shall annually certify to the Auditor of Frank-lin County, (hio, the amount necessary to pay the interest with a proportionate amount necessary to be levied in such year for sinking fund purposes so that the interest on such bonds shall be paid as the same accrues and a sinking fund be

provided sufficient to discharge the principal of said bonds when the same becomes due; and what said County Auditor shall compute and ascertain the rate of lawy necessary to provide therefor in each year, and shall place the same upon the tax duplicate for the year for which it is certified and in addition to all other levies.

ed to have said bonds and coupons properly prepared and executed, to sell the same and deposit the proceeds in the Village Treasury in a fund to be designated as "the fund for the improvement of Bullitt Park Place from the north line of Bexley Avenue to the improved roadway of Broad Street," for the purpose of paying the cost of said improvement and for which purpose said money is hereby appropriated.

SECTION 5. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
