

An Ordinance 258

Consenting to the construction by the Board of Commissioners of Franklin County Ohio of a proposed road improvement in the Village of Bexley

Whereas, it is decided by the Board of County Commissioners of Franklin County, Ohio, to improve a portion of Drexel Avenue within the village of Bexley in said county, extending over the following route to-wit: starting at the north line of what is known as Bexley Circle (said circle being a circular parked area at the intersection of Broad Street and Drexel Avenue) and extending through said circle in a southerly direction to the south line of said circle, a distance of 270 feet more or less, said route so described having a width of 30 feet and the center line thereof shall conform to and coincide with the center line of Drexel Avenue north and south of said circle, and

Whereas, the council of said village of Bexley has heretofore straightened and altered said Drexel Avenue at its intersection with said Broad Street by providing for the establishment of a roadway over and along said above described route, and

Whereas the council of said village is willing to consent that said County Commissioners may improve said roadway established through said circle provided that said Commissioners also construct a similar improvement on the roadway established through said circle from east to west along and upon the center line of said Broad Street in said village. Now therefore,

Be it ordained by the council of the village of Bexley, Franklin County, Ohio:

Sec. 1 That said village of Bexley, hereby consents to the construction, by and under the supervision of Board of County Commissioners of Franklin County, Ohio of the said proposed road improvement through said circle in the said village along and upon the above described route; that the improvement when completed shall be of a width of twenty-eight feet between the curbs; and that the consent hereby given is upon the express condition that the said Commissioners shall also construct a similar improvement thirty feet in width between curbs on the roadway established through said circle from east to west along and upon the center line of said Broad Street in said village

Sec. 2 That the clerk of said village be and hereby is instructed to certify a copy of this ordinance to said Board of County Commissioners of Franklin County, Ohio.

Sec. 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
