

Resolution No. 9,

To cancel certain Bonds authorized for the
improvement of Stanberry Avenue and Euclaire Avenue and
Dawson Avenue.

Whereas, the Council of the Village of Bexley Ohio heretofore
adopted ordinances authorizing the issue of bonds in anticipation
of the collection of special assessments for the improvement of
Stanberry Avenue in the sum of \$76,000; and for the
improvement of Dawson Avenue in the sum of \$60,000; and for
the improvement of Euclaire Avenue in the sum of \$79,000; and

Whereas, since the adoption of said ordinances, bids have been
received for the making of said improvements which render it
necessary to issue and sell bonds for the improve-
ments aforesaid in the amounts following and
no more, to-wit: for the improvement of
Stanberry Avenue, bonds in the sum of \$69,000;
for the improvement of Dawson Avenue, bonds in
the sum of \$51,000; and for the improvement of Eu-
claire Avenue bonds in the sum of \$61,000; and

Whereas, the National Bank of Commerce, of
Columbus, Ohio, has bid par and accrued interest
for the bonds authorized to be issued for the improve-
ment of Stanberry Avenue, but is willing and
has agreed to accept and pay for bonds for
said improvement in the sum of \$69,000; and

Whereas, the Cleveland Trinidad Paving
Company has bid par and accrued interest
for \$51,000 of the bonds authorized to be issued
for the improvement of Dawson Avenue, and
also has bid par and accrued interest
for \$61,000 of the bonds authorized to be issued
for the improvement of Euclaire Avenue, Now
Therefore,

Be it Resolved by the Council of the Village
of Bexley, Ohio, that the mayor and clerk of said
village be and they hereby are authorized and directed
to cancel bonds No. 1 to 7 of the bonds authorized
to be issued for the improvement of Stanberry
Avenue; and bonds No. 1 to 11 inclusive, of the
bonds authorized to be issued for the improvement
of Dawson Avenue; and bonds Nos. 1 to 18 inclu-
sive of the bonds authorized to be issued for the
improvement of Euclaire Avenue; and that
the remainder of the bonds, to-wit, Nos. 8 to 76
inclusive for the improvement of Stanberry

Avenue to be delivered to said National Bank of Commerce, and that bonds Nos. 12 to 62, inclusive for the improvement of Dawson Avenue, and bonds Nos. 19 to 99, inclusive for the improvement of Euclaire Avenue be delivered to the Cleveland Trinidad Paving Company or its assigns upon the payment of the principal and accrued interest on said bonds to the time of delivery.

Be it Resolved further that the secretary of the trustees of the parking fund of the village of Bexley, be and he is hereby authorized and directed to cancel of records bonds Nos. 1 to 7 for the improvement of Stanberry Avenue; bonds Nos. 1 to 11 for the improvement of Dawson Avenue and bonds Nos. 1 to 18 for the improvement of Euclaire Avenue.
