

Ordinance #270

To levy special assessments for the improvement of Ashbourne Road and to repeal ordinance #270, establish an Ordinance "To levy special assessments for the improvement of Ashbourne Road" passed October 2, 1917.

13. It is ordered by the council of the Village of Bexley, Ohio:

That to pay the cost and expense hereinafter determined to be specially assessed for the improvement of Ashbourne Road by grading, curbing and paving the roadway, constructing sewer main and furnish proper drainage for such improvement and construction water and sanitary sewer connections from the water main and sanitary sewer in said area to lots and lands fronting and abutting thereon there be levied and assessed on the lots and lands hereinafter described and fronting and abutting on said improvement the several amounts herein after set forth, to wit:

Section 2 *For* That the assessment levied against each lot or parcel of ground as hereinbefore set forth and described, shall be payable in ~~one equal~~ annual installments with interest thereon at the rate of six percent (6%) per annum payable semi-annually from April 1 - 1918 at the office of the Treasurer of Franklin County, Ohio after the same has been certified to the County Auditor for collection in the manner provided by law.

Section 3 That said assessments and all portions thereof when collected shall be laid in the sinking fund and shall be applied to the payment of bonds issued in anticipation of the collection of assessments for said improvement and the interest thereon on the same shall become due and to no other purpose whatever.

Section 4 That ordinance # 171 passed October 2-1917, entitled any ordinance "To levy special assessments for the improvement of Ashdown Road" is and the same is hereby repealed.

Section 5 This ordinance shall take effect and be in force from and after the earliest time allowed by law.
