AN ORDINANCE NO. 799

By Mr. Albion

To levy special assessment for the construction of a main drain or sewer and branch main drains connecting therewith for surface and storm water drainage.

BE IT ORDAINED by the Council of the village of Exley, state of Ohio, three-fourths of all members concurring:

SECTION 1. That the assessment of the cost and expense of constructing a main drain or sewer and branch main sewers or drains connecting therewith for the purpose of furnishing surface and storm water drainage in said village, as reported to the council on the 6th day of August, 1921, by the board heretofore appointed to estimate said assessment be and the same is hereby adopted, and that there be levied and assessed upon the lots and lands hereinafter described, the several amounts herein set forth to-wit:-

which assessments are in proportion to the benefits accruing to the property assessed.

SECTION 2. That the total assessments against each lot or parcel shall be payable in cash as provided by law, or in five annual installments with interest at the rate of six per centum <sup>Payable Semi-annually from October 1, 1921</sup> (6%) per annum upon deferred payments at the option of the owner. All cash payments shall be made to the village treasurer; all installments of assessments shall be certified by the clerk of the council to the county auditor on or before the second Monday in September, each year to be by him placed upon the tax duplicate and collected as other taxes are collected. If said installments of assessments are not paid when the same become due, a penalty will be imposed and collected as provided by law.

SECTION 3. That said assessments and all portions thereof when collected, shall be applied to his payment of the bonds issued for said improvement and the interest thereon, as the same become due and to no other purpose.

SECTION 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
