AN ORDINANCE NO. 300

To levy special assessment for the construction of the main sanitary sewer in sewer districts Nos. 3 and 4.

BE IT ORDAINED by the Council of the village of Bexley, state of Ohio, three-fourths of all members concurring:

SECTION 1. That the assessment of the cost and expense of constructing the main sanitary sewer in sanitary sewer districts Nos. three (3) and four (4) in said village as reported to the council on the 6th day of August, 1921, by the board heretofore appointed to estimate said assessment be and the same is hereby adopted, and that there be levied and assessed upon the lots and lands hereinafter described, the several amounts herein set forth to-wit:-

which assessments are in proportion to the benefits accruing to the property assessed.

SECTION 2. That the total assessments against each lot or parcel shall be payable in cash as provided by law, or in five annual installments with interest at the rate of six per centum (6%) ^{payable semi-annually from October 1st 1921} per annum upon deferred payments at the option of the owner. All cash payments shall be made to the village treasurer, all installments of assessments shall be certified by the clerk of the council to the county auditor on or before the second Monday in September, each year to be by him placed upon the tax duplicate and collected as other taxes are collected. If said installments of assessments are not paid when the same become due, a penalty will be imposed and collected as provided by law.

SECTION 3. That said assessments and all portions thereof when collected, shall be applied to his payment of the bonds issued for said improvement and the interest thereon, as the same become due and to no other purpose.

SECTION 4. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
