## Resolution No. 266.

Declaring it necessary to construct sawers in part of sanitary sewer district No. 4.

Be it resolved by the Council of the Village of Bexley, State of Chio:

hereinafter described of the sewers provided for in an amended plan for a system of sewers for said village and designated as sanitary sewer district No. 4, which amended plan was adopted by the Council on the 15th day of March, 1921, and is now on file in the office of the clerk of said village; and that the portion of the work provided for in said amended plan, which it is hereby determined to construct is as follows:

An eight inch sewer in the alley between Cassady Avenue and Ardmore Road commencing at a man-hole in center of Powell Avenue six feet west of the center line of said alley; thence extending north in said alley and six feet west of the center line thereof to a manhole six feet south of the center line of the first alley south of Broad Street.

Section 2. That said sewer shall be constructed of vitrified sewer pipe and brick manholes with iron covers, in accordance with plans and specifications, on file in the office of the village clerk.

Section 3. That the whole cost of constructing said sewer shall be assessed by the foot front upon the following described lots and lands, to-wit: All lots and lands fronting, bounding and abutting upon the proposed improvement, which said lots and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to the cost thereof.

in five equal annual installments, with interest at six per cent (6%) per annum payable semi-annually; provided, however, if bonds or notes of said village are issued in anticipation of the levy and of the collection of said special assessments, and such bonds or notes bear a rate of interest less than six per vent. (6%) per annum, then such deferred payments shall bear the same rate of interest as is borne by such bonds or notes.

Section 5. That the clerk be and he hereby is directed to cause this resolution to be published in the manner provided by law. Adopted February 14, 1922.

Be It Resolved, By the council of the Village of Bexley, State of Ohio:
Section I.—That it is necessary to construct a certain part hereinafter described of the sewers provided for in an amended plan for a system of sewers for said village and designated as Sanitary Sewer District No. 4. which amended plan was adopted by the council on the 15th day of March, 1931, and is now on file in the office of the clerk of said village; and that the portion of the work provided for in said amended plan, which it is hereby determined to construct is as follows:

An eight-inch sewer in the alley between Cassady Avenue and Ardmors Road, commencing at a manhole in cepter of Powell Avenue six feet west of the center line of said alley; thence extending north in said alley and six feet wost of the center line thereof to a manhole six feet south of the senter line of the first alley south of Broad Street.

Sec. 2—That said sewer shall be constructed of vitrified sewer pipe and brick manholes with iron covers, in accordance with plans and specifications, on file in the office of the village clerk.

Sec. 3—That the whole cost of constructing said sewer shall be assessed by the foot front upon the following described lots and lands, towit; All lots and lands fronting, bounding and abutting upon the proposed improvement, whi h said lots and lands are hereby determined to be specially benefited by said improvement, and in an amount equal to the cost thereof.

Sec. 4—That the assessments so to

Sec. 4—That the assessments so to be levied shall be paid in five equal annual installments, with interest at six per cent (6%) per annum, payable semi-annually; provided, however, if bonds or notes of said village are issued in anticipation of the levy and of the collection of said special assessments, and such onds or notes bear a rate of interest less than six per cent (6%) per annum, then such deferred payments shall bear the same rate of interest as is borne by such bonds or notes.

Sec. 5—That the clerk be and he hereby is directed to cause this resolution to be published in the manner provided by law.
