RESOLUTION NO. 273.

Directing the preparation of plans for a sewer district to be designated as Sever District No. 5.

Be it resolved by the Council of the Village of Bexley. Chio: That the plans heretofore devised for the sewerage of that part of the Village of Bexley, Chio, included in the boundaries of Sewer Districts Nos. 1, 2, 5 and 4, heretofore established, be amended by creating a new sewer district to be designated as Sewer District No. 5, for the purpose of furnishing sanitary sewerage to that part of the village bounded and described as follows:

> Reginning at a point in the present north corporation line of the Village of Bexley, Chio, said beginning point being the north-east corner of Samitary Sewer District No. 3; thence with the present corporation line easterly; themse southerly; themse easterly; themse southerly and thence easterly to the intersection of the corporation line with the Marian-Trure Township line; thence southerly with said Township line (the same being the east corporation) to a point where the same intersects the south corporation; thence westerly with the south corporation line to a point where the same is intersected by the center line of Roche Avenue produced, said point being the south-east corner of Sanitary Sewer District No. 4: Thence northerly with the east boundary line of Smitary Sewer Districts numbers Four and Three to the place of beginning.

Be it further resolved that the engineers of said village be and they are hereby directed to devise and form a plan for the sewerage of said Sewer District No. 5. showing the size, location, inclination and depth of all main sewers and branch sewers connected therewith and report the same to this council for comfirmation.
