To construct a sidewalk on the East and West side of Drexel Avenue from Main Street to Dale Avenue, and to repeal Resolution No. 244 entitled a resolution, "To construct a sidewalk on the East and West side of Drexel Avenue from Main Street to Dale Avenue," adopted September 20, 1921.

Be it resolved by the council of the Village of Bexley, Ohio:

That a sidewalk shall be constructed on the east and west side of Drexel Avenue from Main Street to Dale Avenue in said village of the character and in the manner following:

Said sidewalk shall be five (5) feet in width, constructed of cement upon a concrete foundation in accordance with the general plans and specifications for the construction of sidewalks on file in the office of the clerk of said village and the outer line thereof shall be the number of feet from the curb line as provided by ordinance No. 354, passed July 11, 1922.

That the clerk of said village be and he hereby is directed to cause a written notice of the passage of this resolution to be served as required by law.

That resolution No. 244 entitled a resolution "To construct a sidewalk on the east and west side of Drexel Avenue from Main Street to Dale Avenue", adopted September 20, 1921, be and the same hereby is repealed.

You are hereby notified that in accordance with a resolution adopted by the Council of the Village of Bexley, State of Ohio, you are required to construct a sidewalk in front of your premises on Laurel Avenue between Main Street and Dale Avenue of the character and in the manner following:
