

A RESOLUTION NO. 303. ✓

Declaring it necessary to improve Mound Street between Pleasant Ridge Avenue and Euclaire Avenue in the Village of Bexley, Ohio, by constructing therein a six (6) inch water main, with necessary fire hydrants.

Be it Resolved by the council of the Village of Bexley, State of Ohio;

Section 1. That it is necessary to improve Mound Street between Pleasant Ridge Avenue and Euclaire Avenue, by constructing therein, between the points aforesaid, a six inch water main, with the necessary fire hydrants, in accordance with the plans, specifications, estimates and profiles of the proposed improvement, prepared by the engineers of said village and now on file in the office of the village clerk, which plans, specifications, profiles and estimates are hereby approved.

Section 2. That the grade of said street as improved shall be the existing grade.

Section 3. That the whole cost of said improvement less one-fourth thereof shall be assessed by the front foot upon the following described lots and lands to-wit: Lots numbered four (4), five (5) and six (6) of Wells' Heirs' Subdivision owned by J. P. and C. V. Mason and fronting three hundred and seventy (370) feet on the north side of Mound Street and lots numbered twenty-nine (29) and thirty (30) of Hamilton's Garden Addition to said village, except one hundred and fifty (150) feet off of the west end thereof, owned by F. C. McVey and fronting three hundred and ninety-three and sixty hundredths (393.60) feet on the south side of Mound Street.

Section 4. That the assessments so to be levied shall be paid in five equal annual installments, with interest on deferred payments at the same rate as shall be borne by the bonds to be hereafter issued in anticipation of the levy and of the collection of such assessments.

Section 5. That bonds of said village shall be issued in anticipation of the levy and of the collection of said assessments and in an amount sufficient to pay that portion of the estimated cost of said improvement hereinbefore determined to be specially assessed.

Section 6. That the remainder of the costs of said improvement to-wit: one-fourth shall be paid from the proceeds of bonds of said village, issued

in the manner provided by law, or from the street improvement fund of said village.

Section 7. This resolution shall take effect and be in force from and after the earliest period allowed by law.
