RESCLUTION NO. 319

Declaring it necessary to impreve Seneca Park Place between Dawsen Avenue and Cassady Avenue.

WHEFEAS, the ewners of all of the lets and lands fronting, bounding and abutting on Senece Park Place, between Dawson Avenue and Cassady Avenue, in the Village of Bexley, Chie, have filed with the council of said village their written petition for the improvement of said Senece Park Place, and

"That the entire cost of said improvement except only such portion thereof as is by law chargeable against the Village, may be assessed and collected in equal annual installments in proportion to the whole assessment in the manner which may be fixed by the Council ", and

whereas, said ewners also "consent and request that said assessments be levied and collected without reference to the value of the preparty" of said ewners "and waive all benefits of the prevision of Section 5918 of the General Code limiting assessments to thirty-three and one-third per cent of the value of the preparty assessed for any and all purposes within the period of five your and also waive all benefits of the previsions of Sections 3814, 3818 and 3895 of the General Code providing for the smervice and publishment of making and levying of the assessment therefor".

NOW THEREFORE, be it resolved by the carried of the Village of Bexley. State of Chie:

Section 1. That it is necessary to improve Seneca Park Place between Dawser Avenue and Cassady Avenue in said village, by grading, curbing and improving the readway with brick, asphalt, bitulithing, tarvia concrete or some other form of permanent improvement, constructing the necessary sterm sewers to furnish proper drainage for such improvement, constructing a six inch water line with necessary fire apparents in said avenue between the points aforesaid, and making water connections therefrom to the lots and lands fronting and abutting thereon, in accordance with the plans, specifications, estimates and profiles of the proposed improvements prepared by the engineers of said village and new on file in the effice of the village clerk, which plans, specifications, estimates and profiles hereby are approved.

Section 2. That the grade of said avenue as improved shall be

the grade shown by and upon the plane and profiles aforesaid, and the grade of the curbs shall be as follows, to-wit:

North and South Curbs--

Beginning at the east preperty line of Dawsen Avenue, Station 0400 and elevation 108.28; thence easterly with a 0.356% ascending grade to the west preperty line of Cassady Avenue, Station 5452.5 and elevation 110.25

Abeve elevations refer to Village Datum.

Section 3. That the whole cest of said improvement, less one-fiftieth (1/50) thereof and the cost of intersections, shall be assessed in propertion to the benefits which may result from said improvement upon the following described lets and lands to-wit: All of the lots and lands bounding, fronting and abutting apen said proposed improvement, which said lots and lands hereby are determined to be specially benefited by said improvement and in an amount equal to that part of the estimated cost thereof hereby determined to be assessed thereon.

Section 4. That the assessments so to be levied shall be paid in not less than nine or more than ten equal annual installments, with interest on the deferred payments at the same rate as shall be berne by the bends to be hereafter issued in anticipation of the levy and of the collection of such assessments.

Section 5. That bends of said village shall be issued in anticipation of the levy and of the collection of said assessments, in an amount sufficient to pay that portion of the estimated cost of said improvement hereinbefore determined to be assessed upon the property fronting and abutting thereon.

Section 6. That the remainder of the cost of said improvements shall be paid either from the proceeds of bends of said village issued in the manner provided by law, or from the street improvement funds of said village.

Section 7. This resolution shall take effect and be in force from and after the earliest period allowed by law.
