

## An Ordinance No. 322.

By Mr. Frye.

To levy special assessments for the improvement of Euclaire Avenue from Main Street to Livingston Avenue, and to repeal ordinance No. 297 passed September 12th, 1921.

Be it ordained by the Council of the Village of Boxley, Ohio:

Section 1. That to pay the portion of the cost and expense heretofore determined to be specially assessed for the improvement of Euclaire Avenue from Main Street to Livingston Avenue in said village, by grading, curbing and paving the roadway with brick, asphalt, bitulithic, tarvia, concrete or some other form of permanent improvement, constructing sewers necessary to furnish proper drainage for such improvement and laying water mains in said Euclaire Avenue and making water connections to the lots and lands fronting and abutting thereon, there be and hereby is levied and assessed upon the lots and lands hereinafter described, and fronting and abutting upon said improvement, the several amounts set forth, to-wit:

Section 2. That the assessments levied against each lot or parcel of ground as hereinbefore set forth and described, shall be payable in ten equal annual installments with interest thereon at the rate of six per cent. (6%) per annum payable semi-annually from October 1, 1921, at the office of the Treasurer of Franklin County, Ohio, after the same has been certified to the County Auditor for collection in the manner provided by law.

Section 3. That said assessments and all portions thereof when collected shall be paid in the sinking fund and shall be applied to the payments of bonds issued in anticipation of the collection of assessments for said improvement and the interest thereon as the same shall become due and to no other purpose whatsoever.

Section 4. That ordinance No. 287 passed September 12, 1921, be and the same hereby is repealed.

Section 5. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
