

An Ordinance No. 324.

To levy special assessments for the improvement of Stanbery Avenue from the north line of Broad Street to the south line of Maryland Avenue, and to repeal ordinance No. 272, passed March 15, 1921 and ordinance No. 295, passed August 12, 1921.

Be it ordained by the council of the Village of Berley, Ohio:

Section 1. That, to pay the cost and expense heretofore determined to be specially assessed for the improvement of Stanbery Avenue from the north line of Broad Street to the south line of Maryland Avenue, by grading, curbing and paving the roadway, constructing sewers necessary to furnish proper drainage for such improvement and constructing water and sanitary sewer connections from the water main and sanitary sewer in said avenue to the lots and lands fronting and abutting thereon there be levied and assessed on the lots and lands hereinafter described and fronting and abutting on said improvement the several amounts hereinafter set forth, to-wit:

Section 2. That the assessments levied against each lot or parcel of ground as hereinbefore set forth and described, shall be payable in *twenty* equal annual installments with interest thereon at the rate of six per cent. (6%) per annum payable semi-annually from October 1, 1921, at the office of the treasurer of Franklin County, Ohio, after the same has been certified to the County Auditor for collection in the manner provided by law.

Section 3. That said assessments and all portions thereof when collected shall be paid in the sinking fund and shall be applied to the payment of bonds issued in anticipation of the collection of assessments for said improvement and the interest thereon as the same shall become due and to no other purpose whatsoever.

Section 4. That ordinance No. 169 passed October 2, 1917, entitled an ordinance "To levy special assessments for the improvement of Stambery Avenue from the north line of Broad Street to the south line of Maryland Avenue," be and the same is hereby repealed.

Section 5. That ordinance No. 272 passed March 15, 1921, and ordinance No. 295 passed August 12, 1921, be and the same hereby are repealed.

Section 6. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
