An Ordinance Mo. 328.

Determining to proceed with the improvement of Cassingham Road from Elm Avenue to the first alley south of Broad Street by the construction of a water line therein.

Be it ordained by the Council of the Village of Bexley, State of

Chio:

Section 1. That it is hereby determined to proceed with the improvement of Cassingham Read from Elm Avenue to the first alley south of Broad Street, in said village, by constructing therein a six inch water line with necessary fire hydrants, together with an eight (6) inch water line in Rowell Avenue from Archaere Road to Cassingham Road, to tie in the line to be constructed in Cassingham Road with a line to be constructed in Powell Avenue from Cassady Avenue to Archaere Road, in accordance with the plans, specifications, profiles and estimates for said proposed improvement prepared by the angineers of said village, heretofore approved and on file with the village clerk, and in pursuance of the resolution declaring it necessary to improve said Road, adopted February 14, 1922.

Section 2. That all claims for damages resulting from said improvement shall be judicially inquired into after the completion thereof, and the Solicitor be and he hereby is authorized and directed to institute preceedings in a court of competent jurisdiction to inquire into such claims.

Section 3. That the whole cost of said improvement less enefiftieth (1/50) thereof shall be assessed by the front foot, upon the following
described lots and lands, to-wit: All of the lots and lands fronting upon said
proposed improvement which lots and lands are hereby determined to be specially
benefited by said improvement, and in the amount hereby determined to be specially
assessed thereon.

Section 4. That the assessments so to be levied shall be paid in five equal annual installments with interest upon the deferred payments at the same rate as shall be borne by the bonds to be issued in anticipation of the levy and of the collection of such assessments.

Section 5. That bonds of said village shall be issued in anticipation of the levy and of the collection of assessments by installments, and in an amount sufficient to pay that portion of the estimated cost of said improvement for which the special assessments are to be levied.

Section 6. That the remainder of the cost of said improvement shall be paid from the proceeds of bonds issued by said village in the manner

provided by law, or out of the water fund of said village.

Section 7. That the clerk be and hereby is authorized and directed

to advertise bids for the construction of said improvement according to law.
